That as per provision of Haryana State Education, School Cadre (Group-B) Service Rules-2012, the requisite qualification for promotion to the post of PGT Mathematics is as under:-

**PGT Mathematics**

**By promotion**

- (i) M.A/M.Sc. Mathematics/Applied Mathematics with Mathematics as one of the subject at Graduation level with atleast 50% marks and B.Ed from recognized university;
- (ii) 2 years teaching experience as TGT Mathematics.

That as per Haryana State Education, School Cadre (Group-B) Service Rules-2012, you do not possess the requisite qualification for being promoted as PGT Mathematics. However, you have been inadvertently promoted by the department. It has come to the notice of the department that some other civil writ petitions have also been filed in the Hon'ble High Court by the employees/ petitioners claiming therein the erroneous benefit contrary to provisions of the service rules on the ground that the said benefit has already been given to the officials. It is a settled law that negative equality cannot be invoked i.e. erroneous benefit given by the department by misreading the service rules or given in pursuant to some judicial orders which are contrary to the provisions of service rules cannot be a ground for other employees to claim the erroneous benefit. Thereafter, on checking the record of the department, it was found that you do not possess the required qualification as per Haryana State Education, School Cadre (Group-B) Rules, 2012 of the department.

So, it is clear that you were not eligible for promotion on the basis of your qualification. However, office erroneously promoted you to the post of PGT Mathematics.

Keeping in view the above facts, the officials who have been inadvertently promoted to the post of PGT Mathematics are liable to be reverted. Before doing so you are served upon a notice of reversion. You are hereby directed to submit your reply if any, in this regard within 15 days from the receipt of this notice. If you do not submit your reply within 15 days from the date of receipt of this notice, the department will decide the matter ex-parte.
