Whereas Sh.Dalbir Singh, TGT (Social Studies) was transferred from GMSSSS Ganaur (Sonapat) to GMS Machhari (Sonapat) vide this Directorate Order No.7/175-2014 HRM-II (3) dated 20.08.2014 but he could not be got joined there, due to paucity of work load. He reported back to his old school i.e. GMSSSS Ganaur (Sonapat) for joining but the Principal concerned refused to get him joined, resultantly thereon, the TGT concerned remained on road. He represented to higher authorities for his adjustment/posting order. Considering all facts, he was adjusted at GSSS Garhi Jhanjhara (Sonapat) vide order dated 04.08.2015 endorsed on 14.08.2015. Consequently thereon, he joined at GSSS Garhi Jhanjhara (Sonapat) on 16.08.2015 but now he is posted at GMS Pabsara (Sonapat). In this way the TGT concerned remained on road from 23.08.2014 to 15.08.2015. He applied to get this on road period condoned as duty period on grounds of no posting order(s).

Consequently, the matter has been examined. The TGT concerned is found entitled to condonation of this period as there is no fault on his part.

Accordingly, the above said period (i.e. 23.08.2014 to 15.08.2015) is hereby condoned under Rule 9.19 (a) read with Sr.No.54 of Table described under Rule 15.1 of Punjab Civil Services Rules Volume-I Part-I read with Rule 82 of Haryana Civil Services (General) Rules, 2016 as it was applicable then. He is entitled to get this period counted as qualifying service for all intents and purposes including pay arrears.






