



Whereas, Sh. Satbir Singh [070593] rendering service on post of S.S Master, Government Middle School Kahlpia now at Government Girls Senior Secondary School Ahulana Distt Sonapat joined his services as regular incumbent on 12.01.1996 on post of JBT now PRT. Being a JBT/PRT of reserved category of scheduled caste, he has been granted promotion to post of Head Teacher, Primary school on 05.09.2002 on completion of 6 years service. Thereafter, he has again been granted fresh promotion from post of JBT to post of S.S Master vide order No. 2/21-2004-HRM-I(4) dated 01.07.2006 and joined on 07.07.2006. It means that he has voluntarily relinquished the post of Head Teacher since there is no provision to grant promotion to post of S.S Master from post of Head Teacher and he was granted 1st ACP grade 9300-34800+GP4800 as Head Teacher w.e.f. 01.10.2012 vide Director Elementary Education Haryana Panchkula Order No. 5/2311-2014 HRM-II(4) dated 18.12.2014.


The entitlement for grant of 1st ACP Pay scale was to be considered in light of statutory financial rules, issued by Finance Department Haryana vide notification dated 07.01.1998/30.12.2008 or 28.10.2016. He is not covered under Rule 7(i), 7(ii), 7(iii), 7(iv) & as per Rule 13 of ACP Rule 2008 and also as per Note-2 below rule 13 of Haryana Civil Services (Pay) Rules, 2016, the 2nd ACP pay scale can only be granted on completion of 16 years regular satisfactory service on promotional post. But in the case of Sh. Satbir Singh, he got two promotions from feeder cadre of JBT Teacher i.e. Head Teacher in the year 2002 and consequently to post of SS Master in the year 2006. You have willingly joined the post of SS Master without any prior permission of this Department, resultantly, the post of Head Teacher became an Ex-Cadre post. On joining on the post of SS Master, your pay had to be fixed from feeder cadre of JBT Teacher but the same was done inadvertently by the field offices which is required to be rectified and re-fixed. But before doing so, Sh. Satbir Singh was issued show cause notice vide this office letter Memo No. 17/69-2018 HRM-II(6) dated 23.07.2018 to submit his reply, within a period of 15 days, receipt of this notice. If no reply/ defence is received within stipulated time period, it would be presumed that you have nothing to submit and further action of rectification of pay fixation would be done ex-parte. Sh. Satbir Singh submitted reply on 24.09.2018. He failed to submit any concrete material in form of documents and rules which may hold him entitled for grant of 1st ACP w.e.f. 01.10.2012 as Head Teacher on completion of 10 years regular satisfactory service in a pay scale of TGT Cadre.

Considering the claim of Sh. Satbir Singh, it has been found that he has been granted promotion from feeder post of JBT to Head Teacher on 05.09.2002 and thereafter he has been granted 2nd benefit in form of 1st ACP as Head Teacher on 01.10.2012. Since Sh. Satbir Singh has opted pay scale of Head Teacher even after joining on post of SS Master on 07.07.2006. Therefore, the claim of 1st ACP w.e.f 01.10.2012 as Head Teacher is not admissible to him and he is not covered under Rule 7(i), 7(ii), 7(iii), 7(iv) & as per Rule 13 of ACP Rule 2008 and also as per Note-2 below rule 13 of Haryana Civil Services (Pay) Rules, 2016. Same is to be rectified. He is admissible to get 2nd ACP w.e.f 04.03.2014 as JBT on completion of 16 years regular satisfactory services.

In view of the above, the pay of Sh. Satbir Singh, S.S Master, Government Middle School Kahlpna now at Government Girls Senior Secondary School Ahulana Distt Sonapat be rectified and re-fixed.


