Whereas Sh. Hari Om (1002474) JBT Teacher who was transferred from Government Primary School, Jhinjar (10782), Block Baund Kalan, District Bhiwani to Government Primary School, Bhidwan (10907), Block Siwani, District Bhiwani due to longer stay as per New Transfer Policy 2016 through on line transfer.

The petitioner i.e. Sh. Hari Om had filed CWP No. 20999 of 2016 in the Hon'ble High Court with prayer that the impugned order of transfer dated 17.09.2016 (Annexure P-4) of respondent No. 3 being issued by exercising the colourable exercise of power, though the petitioner had been denied the same place of posting despite being higher in merit and on the same footing with respondent No. 3 in age without any reason and rhyme. Further for the issuance of a writ in the nature of mandamus directing the respondent No. 3 at Govt. Girls Primary School, Ranila, District Bhiwani and to accommodate the petitioner at the same school being higher in merit with all other consequential benefit.

The above CWP was fixed for hearing on 02-08-2018 in the Hon'ble High Court and the Hon'ble High Court passed the following order in same day:-

**"In view of the above factual position, the present petition is allowed and order of transfer dated 17.09.2016 (P-5) is quashed and a direction is given to the respondents to adjust the petitioner at Government Girls Primary School, Ranila, District Bhiwani forthwith from the date of receipt of certified copy of this order, being higher in merit to respondent No.3."**
