3. The Terms of Reference of the Empowered Committee would be as under:

- i) Access, safety, hygiene and quality aspects in the implementation of the MDMS.
- ii) Mechanisms in place for ensuring convergence with Ministry of Health and Family Welfare, Food & Public Distribution, Drinking Water & Sanitation, Rural Development and Panchayati Raj etc.
- iii) Governance mechanisms in place and their effectiveness in the implementation of MDMS.
- iv) Review mechanisms in place to ensure effective monitoring and evaluation of the scheme.
- v) Mechanisms in place for community participation in the Scheme and its effective monitoring.

4. The Committee shall have the power to constitute Sub-Committee(s) on specific subject(s). The Empowered Committee shall meet at least once in three months. The Committee shall co-opt any expert as special invitee as may be deemed necessary.

5. The secretariat support to the Committee will be provided by the Elementary Education Bureau-I of the Department of School Education & Literacy, Ministry of HRD.

6. The non-official members of the Committee will be paid TA/DA as per GOI's norms.


