Subject:- Inter-District transfer policy (Appointment by transfer) of district cadre teachers i.e. JBT and C&V teachers working on regular basis.

The Govt. has approved the inter-district transfer policy for the JBT and C&V Cadre Teacher who are working on regular basis.

## PROCEDURE OR APPLICATION

- Application forms for individual/mutual (appointment by transfer) shall be available on website i.e. www.harprathmik.gov.in.
- 2 Application should reach concerned DEEOs by 17.12.2012 to 06.01.2013.
- The applications of mutual inter-district transfer should be countersigned by the DEEO(s) of the districts. The terms and conditions will be as under:-
  - (i) Both the teachers will submit their options in writing for mutual transfer.
  - (ii) Both the teachers will state in their affidavits that they are ready to lose their seniority in their previous district and agree with the new seniority at the tail in the new district and their Lien will deemed to be terminated automatically on joining the new district.
  - (iii) The mutual transfer will be effective from the date of joining in new districts. If one teacher will not join during the prescribed period then the appointment by transfer of both the teachers will automatically lapse and both will have to join at their earlier stations.
  - (iv) No TA/DA will be admissible to such teachers.
- 4. Mewat District candidates shall be considered like other Districts candidates.
- 5. No. application form from Adhoc/contractual/Guest teachers of JBT and C&V Teacher Cadre will be entertained/accepted.

- 6. The senior most will be given preference for inter-district transfer as and when vacancy arises.
- 7. The seniority of such teachers will be fixed at the tail end of the concerned cadre in the new districts. He/She shall submit an affidavit with regarding to losing his/her seniority in the previous district and to give undertaking not to claim seniority on the basis of service rendered in the previous district to the concerned DEEO with a copy to the respective Directorates.

#### ELIGIBILITY CRITERIA/ORDER OF PREFERENCE:-

- 1 Mutual transfer of the teacher in the same category/Cadre.
- 2 Physically challenged persons and persons who's kids are physically challenged (70% or more) [certificate should have been issued by the Medical Board].
- 3 Widow/Widower/Legally divorced female teacher(s).
- 4 Persons with terminal illness or who's kids are suffering from terminal disease. [The certificate should have been issued by Civil Surgeon/PGI(s)].
- 5 Un-married lady teacher.
- 6 Wife of serving soldier.
- 7 JBT/C&V Female teachers who want transfer in the district where their husbands are working in district cadre under Education Department. All those female JBT/C&V teachers whose husbands are working in district cadre of other departments will also be considered in this group.
- 8 Such JBT/C&V female teachers who got married after joining their service and seek transfer in the district where husband/in-laws are residing.
- 9 Wives of official/officers of Defence/Para-Military forces i.e. Army, Navy, Air-force, BSF, ITBP etc.
- All such female JBT/C&V teachers who seek their transfer in the district where their husbands are working in State Cadre posts of State/Centre Govt./Local Bodies and body corporate.

**Note:** Performa of Mutual transfer is placed at 'A' and for other transfer at 'B'.

All DEEOs' shall prepare the proposal/Merit list in triplicate after sorting out the application forms as per given criteria and guidelines of inter-

district transfer and send the same the respective Directorate by 11.01.2013 through special messenger. Roster-wise vacancy list of C&V/JBT teachers may also be send to the Directorate Elementary Education, Panchkula alongwith the proposal/merit list.

No transfer will be made without the approval of concerned Directorate.
