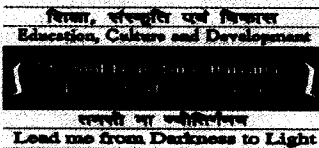

With reference to your application and subsequent correspondence with the school/inspection in this regard, I convey the grant for provisional recognition to Osho International Public School, Ramgarh Rorh (Kurukshetra) for Class 1 to 3 with effect from 01-04-2015 run by Managing Committe, Ch. Dayali Ram Educational & Social Welfare Trust, VPO Ramgarh Rorh (Kurukshetra)

The above sanction is subject to fulfillment of following conditions:-

1. The grant for recognition is Class not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
2. The school shall by the provisions of Right of Children to Free and Compulsory Education Act, 2009 and the Haryana State Right of Children to Free and Compulsory Education Rules 2011.
3. The school shall admit in class I, to the extent of the Strength of that class. Children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion :
