Terms and Conditions

- That this promotion shall be deemed to be revoked and withdrawn if the above newly promoted Demonstrator in Physical Education (PT Master) fails to join their new posting **before 30/11/2015**.

2. That this promotion is subject to the condition that all the particulars and data supplied by the concerned employee and field office is correct. In the event of any information subsequently found to be factually incorrect or erroneous or misrepresented, the promotion so granted shall be withdrawn forthwith without affording any opportunity or assigning any reason.
3. That this promotion is further subject to the condition that the junior most Demonstrator in Physical Education (PT Master) shall be reverted if any senior PTI is found entitled for promotion and is eventually promoted by the Department by virtue of his entitlement for promotion.
4. **The District Elementary Education Officer and Principal of the Concerned School shall personally ensure the following-**
 - a. That this promotion order is being issued against vacant post. The Demonstrator in Physical Education (PT Master) so appointed is advised to report in the Directorate through the concerned District Elementary Education Officer if it is found that the post against which he/she is being appointed is not vacant in the school, so that he/she is adjusted at some other place.
 - b. That this promotion is further subject to the condition that this newly promoted Demonstrator in Physical Education (PT Master) is in possession of the D.P.Ed/B.P.Ed. degree with atleast 3 years' experience as PTI. It shall be obligatory for the District Elementary Education Officer and Principal of the Senior Secondary School to ensure that the verification of the D.P.Ed/B.P.Ed. degree possessed by Demonstrator in Physical Education (PT Master) is carried out. They shall be personally liable for any lapse in this regard. Their verification reports must reach the Directorate before 30/11/2015 positively failing which it shall be presumed that the necessary verification has been carried out by them and newly promoted Demonstrator in Physical Education (PT Master) has been found to be eligible as per rules. **Hence, in the event of any subsequent revelation to the contrary, they shall be held personally liable.**
 - c. That it must be ensured that there exists a sanctioned post and requisite work load in the school where Demonstrator in Physical Education (PT Master) is being posted.

- d. That this promotion is subject to the condition that there is no adverse remark pertaining to integrity in the ACRs of newly promoted Demonstrator in Physical Education (PT Master). This promotion is further subject to the condition that there is no adverse entry in the ACRs which is not available on record as indicated against his name.
- e. That the concerned District Elementary Education Officer will not allow the promotee to join his duties if any complaint/enquiry under Rule-7 of the Haryana Civil services (punishment & appeal) Rules-1987 is pending against him.
- f. That they will be entitled to the benefit of pay fixation and seniority only and no arrears will be paid for this promotion.

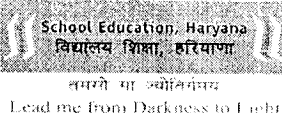

Note :-

- The official will be relieved immediately and in any case within 3 days failing which he/she will be liable for disciplinary action, However if any official is working in Census duty, he/she shall not be relieved till the Census duty is accomplished.
- No TA/DA and joining time will be admissible to the official if he/she has been shifted on his/her request after exercising option.
- No male teacher below the age of 50 years be allowed to join in the girls schools.
- If there is no vacancy in the destination school for any reason the incumbent transferred shall re-join his/her previous place of posting and also inform to concerned branch/computer cell at HQ.
If any discrepancy is noticed in this order or there is a violation of transfer policy, It should be brought to the notice of Computer Cell/Concerned branch within three days and the order be not implemented.
- In case of mutual transfer, it is directed that before relieving/joining the officials concerned, it may be ensured that the distance between both the schools is not less than 8 km.
- In case of urban area stations while implementing the transfer orders, it may be ensured that the transferee has completed the rural service as per transfer policy.
- The mutual transfer would be effective only when both the employees seeking mutual transfer submit a consent document to their respective Principals.


