5. The reimbursement will be made only for chronic diseases declared by Haryana Govt. from time to time.





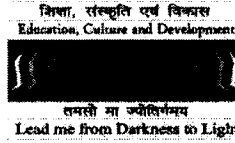
