- 7 The mutual transfer would be effective only when both the employees seeking mutual transfer submit a consent document to their respective Principals.



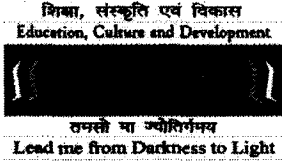


