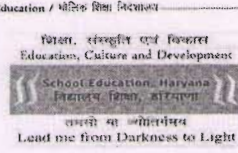

4. **If there is no vacancy and sanctioned post/Workload in the destination school for any reason the incumbent transferred shall re-join his/her previous place of posting and also inform to concerned branch at HQ.**
If any discrepancy is noticed in this order or there is a violation of transfer policy, the concerned DEEO should bring it to the notice of Concerned branch within three days and the order be not implemented.
5. In case of urban area stations while implementing the transfer orders, it may be ensured that the transferee has completed the rural service as per transfer policy.
6. if no workload, transfer may not be implemented.
7. **if DDO makes the transferee Join inspite of without workload & sanctioned post, he will be responsible for the payment of salary to be given to the transferee.**
