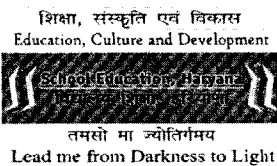

- 6 Head of the Institution may obtain the consent/affidevit of the official that he/she is willing to loose his/her seniority in case of requested transfer orders.




