ORDER

In exercise of the powers conferred upon me under rule 34(1) of Haryana School Education, Rules, 2003, the sanction is hereby accorded for permanent recognition to **New Happy Child Sr. Sec. School, VPO Khor (Gurgaon)** run by Managing Committee, **New Happy Child Education Society, Community Centre, Rewari Road, Khor, Distt. Gurgaon**, for classes from 11 to 12 in subjects of **(Science Only)** under **BOSE** pattern with effect from 01.04.2016 under the following terms and conditions:-

TERMS & CONDITIONS:-

1. This permanent Recognition is granted that on the subject to the condition that the documents/information furnished by the school authorities are factual and not devoid of truth in any way. however, if any information at any stage, is found contrary to the facts the recognition would be revoked forthwith.
2. The school shall follow the course of study as per syllabus prescribed by the affiliated board.
3. The school shall charge fees and funds as declared to the appropriate authority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. In case of any change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipts of fees/funds to the students.
4. Salary shall be paid as per declaration at the time of seeking recognition.
5. No capitation fee and other charges shall be charged from the children/parents.
6. School shall be open for admission without any discrimination based on religion, caste, race, place of birth or any other whimsical.
7. Managing Committee shall not allow to run two schools affiliated by different board/council in the same premises.
8. Managing Committee shall not close down the school or and existing class during the academic session without the prior approval of the appropriate authority.
9. The school shall be open for inspection for the inspecting officer authorized by the Director/Appropriate Authority.
10. Recognition so granted shall be reviewed after every 10 years.
11. No financial assistance shall be granted by the Department to the school.
12. School premises shall not be used for commercial purpose and anti National activities.
13. Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the committee.
14. The Managing Committee shall follow the instructions issued by Government/Director from time to time and supply the information to the Govt./Department as required.
15. In addition to above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules.
16. School will provide ramp within six months otherwise recognition will stands withdrawn.
17. If any information, at any stage found Contrary to the Fact's the recognition would be revoked forthwith.
18. That the number of students in classroom shall not be more than the students calculated on the 10 square feet per student for secondary and Senior Secondary Schools and 9 Square feet per student for elementary state.
19. The managing committee shall abide by the provisions of Haryana School Education Rules 2003(amended) & R.T.E. Rules 2011 and amendments if any thereafter. The Managing shall be liable for disciplinary action in case of violation of any provision of the rules.

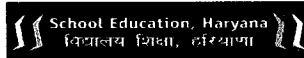

In exercise of powers conferred under Rule 29 (3) read with Rule 3 of Haryana School Education Rules-2003 Education Department, Haryana hereby permit to add new proposed classes for higher stage. However, it is made clear that such permission will not enable such school to get recognition automatically for which the applicant shall have to fulfill the required conditions.

श्री राजेश कुमार सिंगल, प्रधानाचार्य, राजकीय वरिष्ठ माध्यमिक विद्यालय, पारवाला (पंचकूला) के विरुद्ध निदेशालय के आदेश क्रमांक 5/80-2013 एच.आर.जी.-1 (1) दिनांक 01.10.2014 के तहत हरियाणा सिविल सेवा नियम (दण्ड एवं अपील) नियम, 1987 के नियम-8 के अन्तर्गत चार्जशीट जारी करते हुए निम्न आरोप लगाए गए थे:-

“यह कि विभाग ने राठवामाठवि० पारवाला (पंचकूला) को वित्तीय वर्ष 2010-11 व 2011-12 में लाईब्रेरी, कमरा, रैम्य आदि के निर्माण के लिए 11,98,150/-रु० की राशि जारी की थी, परन्तु श्री राजेश कुमार सिंगल, प्राचार्य ने निर्धारित समय अवधि में कोई कार्य नहीं करवाया एवं वह काम करने में अक्षम है।”

उपरोक्त आरोपों का श्री राजेश कुमार सिंगल, प्रधानाचार्य द्वारा दिनांक 23.02.2015 के तहत उत्तर दिया गया। अपने दिए लिखित उत्तर में तथा दिनांक 24.05.2016 को निजी सुनवाई दौरान उन्होंने अपने पर लगाये आरोपों को निराधार बताया तथा सूचित किया कि स्कूल के अन्दर आने वाले बाढ के पानी के लिए निकासी का उचित प्रबन्ध न होने के कारण कमरों का निर्माण नहीं हो पाया। इस बारे उसने जिला उपायुक्त, पंचकूला व कार्यकारी अभियंता को स्थिति से अवगत करवा दिया था। इसके अलावा जहां पर कमरों का निर्माण किया जाना था, वहां पर काफी संख्या में वृक्ष थे, लेकिन वृक्षों को कटवाने में स्कूल प्रबंधन विकासशील कमेटी ने कोई रुचि नहीं दिखाई। इसके अतिरिक्त उस द्वारा समस्त राशि को ब्याज सहित सरकारी खाते में जमा करवा दिया गया। अंततः उसने जानबूझ कर कोई लापरवाही नहीं की और न ही कोई ड्यूटी में कोताही की है।

प्राचार्य द्वारा दिए गये उत्तर व सम्बन्धित रिकार्ड का अवलोकन उपरान्त मैं श्री राजेश कुमार सिंगल, प्रधानाचार्य, राजकीय वरिष्ठ माध्यमिक विद्यालय, पारवाला (पंचकूला) के विरुद्ध नियम-8 के तहत जारी की गई चार्जशीट को ड्राप करने व भविष्य में सचेत रहने की चेतावनी के आदेश पारित करता हूँ।

Subject Recognition Certificate for the School under sub-rule (4) of rule 12 of Haryana State Right of Children to Free and Compulsory Education Rules, 2011 for the purpose of Section 18 of Right of Children to Free and Compulsory Education Act, 2009. .

With reference to your application and subsequent correspondence with the school/inspection in this regard, I convey the grant for provisional recognition to **Apollo International School, Patti Kalyana, Distt. Panipat.** for Class 1 to 8 with effect from 01-04-2016 run by Managing Committee, **Raunaq Education Foundation, 414/1, 4th Floor, DDA Commercial Complex, District Centre, New Delhi.**

The above sanction is subject to fulfillment of following conditions:-

1. The grant for recognition is Class not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII. beyond Class VIII.
2. The school shall by the provisions of Right of Children to Free and Compulsory Education Act, 2009 and the Haryana State Right of Children to Free and Compulsory Education Rules 2011.
3. The school shall admit in class I, to the extent of the Strength of that class. Children belonging to weaker section and disadvantaged group in the neighborhood and provide free and compulsory elementary education till its completion :
Provided, that in case of pre primary classes also, this norm shall be followed.
4. For the children referred to in paragraph 3, the school shall be reimbursed as per sub section (2) of section 12. To receive such reimbursements school shall provide a separate bank account.
5. The school shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
6. The school shall not deny admission to any child for lack of age proof. If such admission is sought subsequent to the extended period specified for admission, the same shall not be denied and the child shall not be discriminated on the ground of religion, caste or race, place of birth or any of them.

The school shall ensure that :-

- (i) no child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;
 - (ii) no child shall be subjected to physical punishment or mental harassment;
 - (iii) no child is required to pass any board examination till the completion of elementary education.
 - (iv) every child completing elementary education shall be awarded a certificate as laid down under rule 22;
 - (v) inclusion of students with disabilities /special needs as per provision of the Act;
 - (vi) the teachers are recruited with minimum qualifications as laid under section 23(1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualification within a period of 5 years;
 - (vii) the teacher performs its duties specified under section 24(1) of the Act; and
 - (viii) the teachers shall not engage himself or herself for private teaching activities.
7. The school shall follow the syllabus on the basis of curriculum laid down by academic authority.
 8. The school shall enroll students proportionate to the facilities available in the school as prescribed 19.
 9. The school shall maintain the standards and norms of the school as specified in section 19 of the Act.

The facilities reported at the time of last inspection are as given under :-

- (i) Area of school campus total built up area.
- (ii) Area of play ground
- (iii) Number of class rooms
- (iv) Room for Headmaster-cum-Office-cum-Storeroom
- (v) Separate toilet for boys and girls

- 10.No unrecognized classes shall run within the premises of the school or outside in the same name of school.
- 11.The school buildings or other structures or the grounds are used only for the purposes education and skill development.
- 12.The school is run by a society registered under the Societies Registration Act, 1860(21 of 1860), or a public trust constituted under any law for the time being in force.
- 13.The accounts should be audited and certified by a Chartered Accountant and proper accounts statement should be prepared as per rules. A copy each of the statements of accounts should be sent to the District Elementary Education Officers every year.
