Terms & Conditions:

1. The mutual inter-district transfer by way of appointment would be affected only when both the employees who are seeking mutual transfer submit a fresh consent in writing.
2. No male official below the age of 50 years be allowed in the girl school.
3. The mutual inter-district transfer by way of appointment will be affected with immediate effect.
4. Before relieving / joining, it will be ensured that the category of both employees is same.
5. The seniority of the candidates who will join in new district will be fixed at the tailed in his cadre in your district. The entry will also be made as transfer by way of appointment in the service book of the employee.
6. No TA/DA will be admissible to the official.
7. That the DEEO is directed to constitute a committee at his own level and to make concealing of the teachers so being transferred that the same are strictly in accordance with the Inter-District Policy and their transfer order on the basis of appointment is to be implemented after obtaining approval of the Directorate.
8. That at the time of approval, all DEEOs are directed to certify that the present mutual transfers of the teachers are in accordance with the Inter District Policy and their documents have been scrutinized / checked by me and found correct.
9. If any discrepancy is noted in this order or there is a violation of inter district transfer policy, it should be brought to the notice of C&V branch of directorate within 7 days and order will not be implemented.
