

Whereas Sh. Joginder Singh[027970], Math Master, Govt Senior Secondary School Butana now serving at GSSS Asadpur Nandnaur (Sonipat) was placed under suspension vide Order No. 14/54-2012 HRM-II(2)/514 dated 19.10.2014 & Reinstated in service pending enquiry vide order dated 27.11.2012. After careful consideration of the facts and reply of the delinquent the suspension period was decided as leave of kind due by the Disciplinary Authority vide order dated 19.11.2015. The delinquent filed the present 1<sup>st</sup> appeal against the said order dated 19.11.2015.

Considering the facts on file and application, the delinquent has been granted opportunity of personal hearing on 10.03.2016. The delinquent heard in person and the submissions made by him seem to be trustworthy as he performed his duties as Math Master from 17.05.2012 to 03.11.2012 and he has been paid salary for this duty therefore, there is no justification to declare this period as leave of kind due. Further the judgment dated 01.09.2015 of Hon'ble Criminal Court reveals that the complainant has retreated from his earlier statement and nothing incriminating has been found against the delinquent Employee. The appellant has never remained under police custody for or more than 48 hours, due to this fact the suspension order dated 19.10.2014 are invalid as per the provisions of Haryana Civil Employees (Punishment and Appeal) Rules, 1987.

After careful consideration of the submissions and facts, I am of the considered view that there is no justification in the order of Disciplinary Authority and the same are hereby reversed and the suspension period of the appellant is ordered to be treated as duty period for all intents and purposes.
