Permission is hereby **granted** to **Sh. Bharat Singh, Science Master, GSSS Rampura Dhillon, District Sirsa** to change the option for the medical reimbursement from open medical allowance to fix medical allowance facility w.e.f. **20.06.2015** in terms of Haryana Government instructions issued from time to time on the following conditions:-

1. That he/she shall not be entitled for fixed medical allowance w.e.f. **20.06.2015** the date of option change and the fixed allowance, if any amount paid to him/her after date of change of option will have to be deposited in Government Treasury.
2. The reimbursement will be made only for chronic diseases declared by Haryana Govt. from time to time.
3. That he/she shall not be entitled for fixed medical allowance as long as he avails open medical allowance facility.
4. That the medical option has been changed since the employ/employee's dependent family member is suffering from chronic disease. The certificate in this regard should be issued by the competent authority defined in the Rules.
5. The Medical Certificate is to be reviewed/renewed after a period of two years or before date of its expiry whichever is earlier otherwise his/her medical option will be changed from open to fixed automatically

- 2 श्री सिद्धार्थ मिश्रा से उनके द्वारा इस ज्ञापन की प्राप्ति की तिथि से 21 दिन की अवधि के अन्दर लिखित रूप में बताने की अपेक्षा की जाती है कि वे सभी आरोपों या उनमें से किसी को स्वीकार करती/करता है या नहीं। उन्होने क्या स्पष्टीकरण या प्रतिवेदन, यदि कोई हो, प्रस्तुत करना हैं और क्या वे व्यक्तिगत रूप में अपनी सुनवाई चाहती/चाहता है।
- 3 श्री सिद्धार्थ मिश्रा को आगे सूचित किया जाता है कि वे अपने लिखित कथन को तैयार करने के प्रयोजन के लिये सुसंगत सरकारी अभिलेखों को देखना चाहती/चाहता है तो उन्हें महानिदेशक मौलिक शिक्षा हरियाणा पंचकूला के कार्यालय में उनके साथ पहले समय नियत करने के बाद, किसी कार्य दिवस को, उनका निरीक्षण करना चाहिए। फिर भी यह बताया जाता है कि उन्हें केवल ऐसे ही दस्तावेज दिखाये जायेंगे, जोकि महानिदेशक मौलिक शिक्षा हरियाणा पंचकूला के पास है और जो मामलों के साथ पूरी तरह से सुसंगत है, यदि सरकार की राय में उन्हें किन्ही दस्तावेजों को दिखाने की अनुमति देना लोकहित में वांछनीय नहीं है, तो उन्हें वह दस्तावेज दिखाने के लिए इन्कार कर दिया जायेगा। यदि श्री सिद्धार्थ मिश्रा ऐसे किसी अन्य सुसंगत अभिलेख को देखना चाहती/चाहता है जो महानिदेशक मौलिक शिक्षा हरियाणा पंचकूला की अभिरक्षा में नहीं है तो उनका निरीक्षण करने की जिम्मेदारी उनकी अपनी है, फिर भी श्री सिद्धार्थ मिश्रा को यह बात स्पष्ट की जाती है कि उनके द्वारा उक्त दस्तावेज का निरीक्षण न किया जा सकना उनके लिखित कथन को भेजने में देरी के लिए वैध आधार नहीं माना जायेगा और यदि लिखित कथन निम्नहस्ताक्षरकर्ता को निर्दिष्ट अवधि के अन्दर प्राप्त नहीं होता तो यह समझा जायेगा कि उन्हें कुछ भी प्रस्तुत नहीं करना है।







Whereas by way of filing CWP No. 7229 of 2016, titled as Dharmender Singh versus State of Haryana & others, the Petitioner had approached Hon'ble Punjab & Haryana High Court at Chandigarh for issuance of a writ in the nature of mandamus directing the respondents for stepping up his pay with his Junior Respondent No. 6, i.e., Gulab Singh, Social Science Master, Govt. Middle School, Khan Mohammad (Fatehabad) and for granting all consequential benefits. The said writ petition came for hearing before the Hon'ble Court on 22-04-2016 and the Hon'ble Court was pleased to dispose of the same. The operative part of this judgment is reproduced here for ready reference:

"The petitioner by way of this petition is seeking directions to the respondent to step up the pay at par with his junior i.e. Respondent no. 6.

In this regard, he has filed a representation dated 10.08.2015 (Annexure P-4) to the respondent department but no decision has been taken thereon.

Learned counsel for the petitioner states, that at this stage, the petitioner will be satisfied, if directions are issued to the official respondent(s) to decide the representation (Annexure P-4), referred to above.

In view of above, without commenting on the merits of the case, this petition is disposed of with a direction to the respondents to decide the representation dated 10.08.2015 (Annexure P-4) by passing a speaking order, in accordance with law, within a period of four months, from the date of receipt of certified copy of this order."

In pursuance of the above, the representation dated 10-08-2015 has been examined in the light of the seniority of the petitioner. The petitioner has submitted in his representation dated 10.08.2015 that he was appointed on 25.10.1995, and is getting pay at the rate of Rs. 20,210+4800-25010 whereas, Sh. Gulab Singh, Junior to him, has been getting pay at the rate of Rs. 21000+5400-26400, i.e., more pay than the petitioner. After due consideration of the service record, it has been found that in pursuance of Haryana Government order Issued vide Letter No. 2/6/90-5GSI dated 16.07.1992, the services of Sh. Gulab Singh were regularized under handicapped quota vide order No. 2/3-1996 E-II(1) dated 21.08.2002 w.e.f. the date of his joining the service, i.e., 1995 whereas the services of the petitioner were regularized w.e.f. 01.10.2003. Therefore, the petitioner is not senior to Sh. Gulab Singh, i.e., private respondent no. 6. As per seniority on 01-01-2016, the seniority number of the petitioner is 8224 whereas Sh. Gulab Singh

(Respondent No. 6) stands at Sr. No. 4757. In this way, the Respondent No. 6 is senior to the petitioner and the petitioner is junior to Respondent No. 6. It is relevant to state here that the Respondent no. 6 has been allowed benefit of 1st ACP pay scale on completion of 10 years of continuous service on 01-02-2005 whereas the petitioner, regularized w.e.f. 01-10-2003, was allowed the benefit of 1st ACP pay scale w.e.f. 01-10-2013 and it has made all the difference in the pay.

After considering all the contents on the file and perusing judgment (supra) of the Hon'ble Court, the petitioner, being junior to respondent no. 6, has no locus standi to claim pay parity with his senior. The petitioner has been paid salary as per his substantive right. There is no merit in the claim of the petitioner. His representation dated 10-08-2015 is, therefore, liable to be rejected.

I pass order accordingly.
