1. That he/she will not be entitled fix medical allowance w.e.f. **01.10.2015** and the fix medical allowance, if any, paid to him/her after the date of change of option will have to be deposited in Government Treasury.
2. That he/she will not be entitled fix medical allowance until he/she avails open medical allowance facility.
3. That the option has been changed since the **employee** is suffering from chronic disease. The certificate in this regard has been issued by **Civil Surgeon Faridabad** vide No. **3 dated 06.02.2015**.
4. The Medical Certificate is to be reviewed/renewed after a period of two years or before date of its expiry whichever is earlier otherwise his/her medical option will be changed from open to fix automatically.
5. The reimbursement will be made only for chronic diseases declared by Haryana Govt. from time to time.

Whereas, Sh. Naresh Kumar submitted an application/request dated 19.01.2015 for resignation from the post of Math Master w.e.f. 01.04.1998 due to his family circumstances. The application/request examine by the office.

The brief facts of the case are that Sh. Naresh Kumar was appointed as Math Master on 22.07.1981 on adhoc basis and his services was regularized w.e.f 16.05.1983 and he worked till 31.03.1998 in different schools and he was not attended the school after 01.04.1998.

Sh. Naresh Kumar, Math Master was chargesheeted under rule 7 of Haryana Civil Services (P&A) Rules 1987 for absent from duty w.e.f. 22.10.1997 without any information and application. The chargesheet was issued by this office on 08.04.2004, but Sh. Naresh Kumar did not submit any reply to the chargesheet. Now he submitted application/request dated 19.01.2015 for drop the chargesheet and to accept the resignation w.e.f. 01.04.1998.

As per Govt. instructions dated 24.10.1972, it is provided that absent from duty by a Govt. servant on the expiry of maximum period of 5 years amounts automatic abandonment of his duty. In this present case the applicant submitted by the applicant prior to this application is not accepted by the competent authority.

That the office proposed that Sh. Naresh Kumar, Math Master was not attended the office after 22.10.1997 and his request for resignation be accepted after dropping the chargesheet and one month salary in lieu of resignation be directed to deposit. However, the Head Master sanctioned the leave without pay till 31.03.1998. Further, as per report of BEO/DEO concerned nothing is pending against Sh. Naresh Kumar including court case except above said chargesheet.

In view of the facts narrated above and going through the relevant rule I being the competent authority accept the request dated 19.01.2015 for resignation w.e.f. 01.04.1998 subject to deposit of one

month salary and the Chargesheet issued on 08.04.2004 is hereby dropped. However, he is entitled for GPF and GIS.
