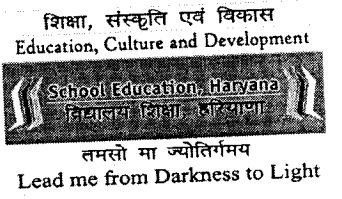

In pursuance of judgment dated 21.01.2014 of Hon'ble Punjab & Haryana High Court, Chandigarh in LPA No.1563 of 2012 in CWP No. 16710 of 2012 titled as Geeta Devi V/s State of Haryana and others, the claim of the Appellant/Petitioner i.e Geeta Devi for the post of S.S. Mistress under Ex-Serviceman (General) (Female) category has been considered in compliance of this judgment (Supra) appointment letter is issued to petitioner i.e Geeta Devi, on the basis of recommendations received from the Haryana Staff Selection Commission No. HSSC/Confid./ Recomm./2012/332 dated 06.06.2012 against advt.4/2009 category no.5 for appointment in Haryana School Education (Group-C) State Cadre Service Rules-2012 on the post of S.S. Mistress in the scale of 9300-34800+GP 4600/-plus other allowances as sanctioned by the Haryana Govt. from time to time on the following terms and conditions.

Terms & conditions:-

1. Her appointment is purely against the temporary post which may be abolished at any time and carry no promise of subsequent employment. No offer of permanent vacancy can be made to her at present in this respect. Her service is liable to be terminated without assignment any reason by giving one month notice or salary in lieu thereof.
2. If at any stage she desire to resign she will be required to give one month's notice or deposit/forfeit one month's salary including allowances in lieu thereof notice for one month's or for the period by which the notice falls short of one month. Such a notice will also be given to her by the competent authority in case it is proposed to terminate her services.

3. No TA/DA will be admissible for joining the post.
4. Before assuming the charge of duty she will be required to take the prescribed oath of allegiance to the constitution of India and to produce the following certificate.
 - a. Medical fitness certificate from the Chief Medical Officer concerned as required under rule 3.1 the Punjab Civil Services Vol. 1 Part-I.
 - b. Certificate to the effect that she is not married to a person having a spouse living or that she will not contract marriage with any person having a spouse living as the case may be.
 - c. Attested copy of Educational & professional qualification and matriculation certificates.
5. She will be put up on probation for a period of two years in the instance from the date she join as mistress. In this behalf besides, her work and conduct her result will be particularly taken into consideration while assessing her performance. If in the opinion of the appointing authority her work and conduct has been not been found satisfactory during probation period. This probation period is liable to be extended provided that the total period of probation including extension shall not exceed three years or her service will be dispensed with.
6. No application for employment outside the department will be considered till the completion of three years service.
7. Her character and antecedents have not been got verified and in case subsequently any adverse facts come to the notice of the State Government regarding her character and antecedents, her service are liable to be terminated in view of the instruction by the Chief Secretary to Govt, of Haryana Vide letter No. 52/9/54-GS (10 dated 7th June 1994.

8. Any pressure for transfer and specially the unwillingness to serve in the interior schools of rural area will entitle the department to terminate the services of such candidate.
9. If she appointed in the urban area inadvertently, she may be allowed to join her duties. In such case candidate will report to the Directorate immediately for another place of posting.
10. It is also made clear that the candidate must assured charge of her appointment within 15 days falling which this offer shall be treated as cancelled.
11. Her appointment is subject to the verification of her degree/'s educational qualification. If her degree are found fake from the un-recognized University, her service will be terminated without giving any notice.
12. If Usha Devi who is at merit no. 275, DESM General female category in the recommendation no. HSSC/Confid./ Recomm./2012/332 dated 06.06.2012 received from Haryana Staff Selection commission come forward to consider her claim for appointment for the post of S.S. Mistress in that case you will have no right to retain in service.
