

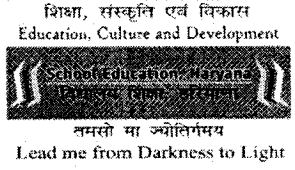

Saturation of students studying in Government Schools as well as Private schools for Aadhaar Identification.

In continuation of memo no 8/41-2015 PS(4) dated, 6.10.2015 issued by Director Secondary Education Haryana on the subject cited above.

The Government of India has mandated to achieve target of 100% saturation of Aadhaar enrolment by the mid of December, 2015.

To achieve the target Department of school education has been assigned the responsibility to ensure 100% Aadhaar saturation of the children studying in Government as well as Private Schools. Instructions for Government schools have already been issued to arrange special camps at cluster level in consultation with Deputy Commissioner concerned.

To take further the drive, you are requested to direct the private schools of your district to encourage the parents to enroll their children for Aadhaar identification and arrange special camps in schools in consultation with the concerned Deputy Commissioner. As district Coordinator of the enrollment campaign, you will have the additional responsibility of carrying out the enrollment of private schools too. Extensive publicity campaigns should be launched to persuade the private schools, parents and teachers to ensure Aadhaar enrollment of the children.
