Permission is hereby granted to **Sh. Om Parkash, S.S. Master, GSSS Kanwali (Rewari)** to change the option for the medical reimbursement from **fix medical allowance to open medical allowance** facility for reimbursement of outdoor expenses of allopathic treatment of chronic disease(s) w.e.f. **01.07.2015** in terms of Haryana Government instructions issued from time to time on the following conditions:-

1. That he/she will not be entitled fix medical allowance w.e.f. **01.07.2015** and the fix medical allowance, if any, paid to him/her after the date of change of option will have to be deposited in Government Treasury.
2. That he/she will not be entitled fix medical allowance until he/she avails open medical allowance facility.
3. That the option has been changed since the **employee** is suffering from chronic disease. The certificate in this regard has been issued by **Civil Surgeon Rewari** vide No. **MG-2015/68 dated 01.07.2015**.
4. The Medical Certificate is to be reviewed/renewed after a period of two years or before date of its expiry whichever is earlier otherwise his/her medical option will be changed from open to fix automatically.
5. The reimbursement will be made only for chronic diseases declared by Haryana Govt. from time to time.

Whereas by way of filing CWP No. 26093 of 2015, the petitioner i.e Satywart Singh son of Sh. Kishan Lal, D.P.E. (Retd.) has approached Hon'ble Punjab & Haryana High Court at Chandigarh for issuance directions to respondents to consider and decide the legal notice dated 10-08-2015 vide which he claimed granting the benefit of Assured Career Progression (i.e. ACP) pay scale as junior to him has been getting more pension to him. The said writ petition came up for hearing before Hon'ble Court on 17-03-2016 and Hon'ble Court pleased to dispose of the same. The operative part of this judgment is reproduced here for ready reference:

"Petitioner was appointed on 09.03.1993 as PTI in Government High School, Kanti and thereafter he was promoted on the post of DPE on 21.02.1995. After completion of 20 years, the petitioner was retired on 31.03.2013 and the benefit of ACP has not been granted to him.

In this regard, the petitioner has issued a legal notice dated 10.08.2015 (Annexure P-3) to the respondent(s) but no decision has been taken thereon.

Learned counsel for the petitioner states, that at this stage, the petitioner will be satisfied, if directions are issued to the respondent(s) to decide the legal notice dated 10.08.2015 (Annexure P-3), referred to above.

In view of above, without commenting on the merits of the case, this petition is disposed of with a direction to the respondent(s) to decide the legal notice dated 10.08.2015 (Annexure P-3), filed by the petitioner, by passing a speaking order, within a period of three months, in accordance with law."

In pursuance of this order dated 17-03-2016, the relevant service record of the petitioner has been sought with remarks from office of District Elementary Education Officer, Narnaul. Perusing the service record, it has been found that the petitioner was appointed on 09.03.1993 as PTI In Government High School, Kanti and thereafter he was promoted on the post of DPE on 21.02.1995. He never completed 20 years of regular satisfactory service as DPE and retired on 31.03.2013. The legal notice (Dated 10-08-2015) served by him has

already been decided and replied vide Memo No. A-1/2015/72 Dated 16-09-2015 by Block Education Officer, Ateli (M. Garh) which has been concealed by the petitioner while filing the writ petition. After considering contents of legal notice dated 10-08-2015 and documents on file, following facts came into light:

1. That the petitioner was appointed as PTI on 09-03-1993 in pay scale of Rs. 1200-2040 (Revised 4500-125-7000 w.e.f. 01-01-1996 and further revised in PB-2 (i.e. 9300-34800) with Grade Pay of Rs. 4200 w.e.f. 01-01-2006).
2. That the petitioner was promoted as D.P.E. and he joined as such on 21-02-1995 in pay scale of Rs. 1400-2600 (Revised 5500-175-9000 w.e.f. 01-01-1996 and further revised in PB-2 (i.e. 9300-34800) with Grade Pay of Rs. 4600 w.e.f. 01-01-2006), in this way, he got a promotion and had availed 2 financial benefit in his service therefore, he is not entitled to get benefit of 1st ACP pay scale (i.e. 5450-150-8000) w.e.f. 01-04-2003 on completion of 10 years regular satisfactory service as PTI as he was already getting salary in pay scale of Rs. 5500-175-9000 with effect from 01-01-1996 as D.P.E..
3. That the petitioner has already been granted benefit of 1st ACP pay scale w.e.f. 01-01-2006 in form of Grade Pay Rs. 4800/- on completion of 10 years service as D.P.E. whereas he would never be entitled to get the 2nd ACP as PTI w.e.f. 01-04-2013, on completion of 20 years regular satisfactory service as he already attained the age of superannuation on or before 31-03-2013.
4. That the Finance Deptt. Notification No. 1/83/2008-1PR (FD) dated 04-03-2014 has been made applicable with immediate effect. There is no provision to implement this order with retrospective effect, moreover, the petitioner already got retired on 31-03-2013, and this notification is not applicable in his case.
5. That the petitioner has not annexed any comparative statement of pay with his junior which may justified his claim, therefore, without such comparative statement, the contents of legal notice dated 10-08-2015 are just surmises and conjectures of petitioner.

After considering all the contents on file and service record of the petitioner, the undersigned is of considered view that the petitioner has no locus standi to claim benefit of 2nd ACP (i.e. Grade Pay-5400/-) as DPE without completion of 20 years service on or prior to 03-03-2014 which he never completed as he retired on 31-03-2013. There is no merit in the claim of the petitioner, resultantly; the claim of the petitioner for further ACP pay scale benefit is liable to be rejected.

I pass order accordingly.
