Whereas Sh. Krishan Kumar was appointed as S.S. Master (070384) at GSSS Bega Sonapat (3546), vide this office order no 24/4 04 HRM-1(1) dated 30.06.2006 against vacancy with immediate effect. He was not allowed the benefit of General Provident Fund (i.e. GPF) by treating him to be an employee after 01.01.2006. He approached Hon'ble High Court by way of filing CWP No. 17826 of 2011 Krishan Kumar V/s State of Haryana. The Hon'ble High Court allowed the writ petition and directed the official respondents to consider the petitioner to have been appointed before 01.01.2006 i.e. the date (13.12.2004) when the candidates of the same selection list were appointed.

Perusing the judgment dated 23.02.2017 and the opinion tendered by Worthy Advocate General Haryana and Id. Legal Remembrancer Chandigarh, the appointment of the petitioner i.e. Krishan Kumar has been reconsidered. He has now been allowed appointment w.e.f. 13.12.2004 notionally with condition that he would refund the employer share deposited by the Govt. under New Pension Scheme.
