

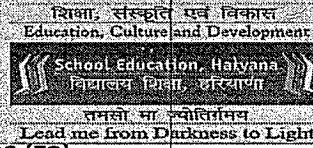

In exercise of powers conferred under Rule 29(3) read with Rule 3 of Haryana School Education Rules-2003 Education Department, Haryana permission is hereby granted to establish a new proposed school on the terms and conditions mentioned below:-

- The Proposed School shall have the required infrastructure regarding land and Building i.e. number & size of class rooms with veranda and other rooms for Head of Institution/ Office, Library, Laboratory, Stairs, Ramp and Toilets etc. as per Rule 30.
- The Management of the school shall have to apply for permanent recognition within the stipulated time in the prescribed form-II with documents as per rule 31.
- The Management shall not make admission beyond Class-III before the sanction of its recognition or in its anticipation.

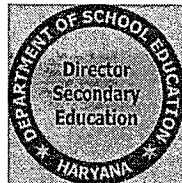



Whereas Nirmala Devi has filed CWP No. 19259 of 2016 titled as Nirmala Devi Versus State of Haryana & others in the Hon'ble High Court, which was decided by the Hon'ble Court on 12.05.2017 by passing the following orders inter alia:-

“Petitioner has sought for directions to the respondents to update the status of the Government Primary School Indergarhi (17808) which has been shown in zone no.5 instead of zone no. 3 with reference to transfer policy-2016 (Annexure P/1) read with communication of the Block Education Officer, Block Gohana, District Sonapat (Annexure P/3). In this regard, petitioner is stated to have sent a legal notice dated 29.08.2016. The concerned respondent is required to take a decision on this issue

The concerned respondent is hereby directed to take a decision on the legal notice and pass a speaking order before the next date of hearing while communicating the same to the petitioner.”

In compliance of order dated 12-05-2017 of the Hon'ble High Court, I have gone through the annexure P-5 dated 29.08.2016. As per this annexure, the petitioner has submitted to rectify the Zone of GPS Indergarhi (17808) Block Gohana, Sonapat which has been shown in zone no. 5, whereas it falls in zone no. 3. She further prayed that this mistake be corrected so that difficulties may not occur.

It is mentioned here that Govt. Primary School Indergarhi was shifted to Saini Dharamshala Baroda Road, Gohana and the same was further shifted to Sector-7, Gohana on 05.09.2009 due to shortage of the space and the same is running in the building of Haryana Urban Development Authority, Sector-7, Gohana, District Sonapat. In the same way, GPS Vishavkarma Colony was also shifted in this building and the same is running in the said building.



It is pertinent to mention here that the above said both schools lie in the same zone i.e. zone no. 3.

It is mentioned here that every teacher who has completed 5 years continuous stay in a particular school shall be transferred.

As per the MIS profile of Smt. Nirmala Devi, she had served in GPS, Indergarhi for 14 years from year 1998 to 2012. The school's zone as per the representation should be zone-3 and if this is considered, she becomes eligible, in addition, to be transferred to zone-5.
