Subject:- Recognition Certificate for the School under sub-rule (4) of rule 12 of Haryana State Right of Children to Free and Compulsory Education Rules, 2011 for the purpose of Section 18 of right of Children to Free and Compulsory Education Act, 2009.

With reference to your application and subsequent correspondence with the school/inspection in this regard, I convey the grant for provisional recognition to **Modern Mother's Pride School, Nuh, Mewat** for class 1st to 8th with effect from 01.04.2017 run by Managing Committee, **Mother's Pride Educational Society, Near Hindu High School, Nuh, Tehsil Nuh, Distt. Mewat.**

The above sanction is subject to fulfilment of following conditions:-

1. The grant for recognition is Class not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
2. The school shall by the provisions of Right of Children to Free and Compulsory Education Act, 2009 and the Haryana State Right of Children to Free and Compulsory Education Rules 2011.
3. The school shall admit in class I, to the extent of the Strength of that class. Children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion:
Provided, that in case of pre primary classes also, this norm shall be followed.

4. For the children referred to in paragraph 3, the school shall be reimburse ed as per sub section (2) of section 12. To receive such reimbursements school shall provide a separate bank account.

5. The school shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procepdure.

6. The school shall not deny admission to any child for lack of age proof. If such admission is sought subsequent to the extended period specified for admission, the same shall not be denied and the child shall not be discriminated on the ground of religion, caste or race, place of birth or any of them.

The school shall ensure that :-

- (i) no child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;
 - (ii) no child shall be subjected to physical punishment or mental harassment;
 - (iii) no child is required to pass any board examination till the completion of elementary education.
 - (iv) every child completing elementary education shall be awarded a certificate as laid down under rule 22;
 - (v) inclusion of students with disabilities /special needs as per provision of the Act;
 - (vi) the teachers are recruited with minimum qualifications as laid under section 23(1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not posses minimum qualifications shall acquire such minimum qualification within a period of 5 years;
 - (vii) the teacher performs its duties specified under section 24(1) of the Act; and
 - (viii) the teachers shall not engage himself or herself for private teaching activities.
7. The school shall follow the syllabus on the basis of curriculum laid down by academic authority.
 8. The school shall enroll students proportionate to the facilities available in the school as prescribed 19.
 9. The school shall maintain the standards and norms of the school as specified in section 19 of the Act.

The facilities reported at the time of last inspection are as given under :-

- (i) Area of school campus total built up area.
- (ii) Area of play ground
- (iii) Number of class rooms
- (iv) Room for Headmaster-cum-Office-cum-Store room
- (v) Separate toilet for boys and girls
- (vi) Drinking Water Facility
- (vii) Kitchen for cooking Mid Day Meal
- (viii) Barrier free Access

- (ix) Availability of Teaching Learning Material /Play Sports Equipments/Library.
- 10.No unrecognized classes shall run within the premises of the school or outside in the same name of school.
- 11.The school buildings or other structures or the grounds are used only for the purposes education and skill development.
- 12.The school is run by a society registered under the Societies Registration Act, 1860(21 of 1860), or a public trust constituted under any law for the time being in force.
- 13.The accounts should be audited and certified by a Chartered Accountant and proper accounts statement should be prepared as per rules. A copy each of the statements of accounts should be sent to the District Elementary Education Officers every year.
- 14.The recognition code Number allotted to your school is **3331/MWT/8th/BOSE/2017**. This may please be noted and quoted for any correspondence with this office.
- 15.The school furnishes such reports and information as may be required by the Director of Education/District Elementary Education Officer from time to time and complies with such instructions of the State Government/Local Authority as may be issued to secure the continued fulfillment of the condition or recognition or the deficiencies in working of the school.
- 16.Renewal of Registration of Society, If any be ensured.
- 17.Other Condition as per Annexure III.

Whereas the appellant i.e. Sh. Kamal Kishore, TGT (Sc.), GSSS Khalilpur, Gurgaon now Gurugram preferred an appeal against punishment order dated 29.12.2014 passed by disciplinary authority i.e. Additional Director Administration, Elementary Education Haryana, Panchkula whereby the punishment of stoppage of one annual increment with cumulative effect was imposed.

Considering all facts on file and contents of appeal, the appellant has been granted opportunity of personal hearing on 28.03.2017. The appellant appeared in person and submitted all relevant record of complaint/FIR, compromise between the parties and order dated 22.01.2014 passed by Hon'ble High Court in CRM-M No.31926 of 2013 wherein the FIR and consequent proceedings conducted on the basis thereof for offences under sections 354, 294 and 506 IPC are quashed.

I have also gone through the enquiry report dated 12.05.2014 and categorically, I perused the statement which the complainant had deposed before Sh. O.P. Garg Inquiry Officer on 07.05.2014. In her statement, she specifically stated that "Sh. Kamal Kishore used to tease me and wanted to have physical sexual relations with me continuously. He also used to threaten me and my husband that he will kill us. He also used to say that if I did not keep physical sexual relation with him, he will upload my photo on the internet after modifying the same and will spoil my married life, that Sh. Kamal Kishore also used to bring sometime gun, sword and rassi and also used to inject drugs in his body and threatened me that I should also inject drugs in my body and threatened to commit suicide so that I may be implicated in some case. This conduct of Sh. Kamal Kishore is unbecoming of him being teacher."

The Inquiry Officer in his enquiry report clearly proved all the charges as levelled against the appellant. I also found that complainant Smt. Anuradha, Sanskrit Teacher has given her statement before the Inquiry Officer on 07.05.2014, whereas, the F.I.R. and other subsequent proceeding has been quashed on 22.01.2014.

After considering the said facts, statement of complainant, enquiry report and order of the Hon'ble High Court, I came to this conclusion that a lenient view may be taken and his punishment of stoppage of one increment with cumulative effect may be modified to one increment without cumulative effect. Hence, I pass the order accordingly.
