Whereas the appellant, Bhim Singh, TGT (Maths), GHS Kohar Distt. Bhiwani now posted at GSSS Hetampura Distt. Bhiwani has preferred an appeal against order of Disciplinary Authority-cum-Additional Director Admn. Elementary Education, Haryana, Panchkula dated 07.04.2017 wherein the suspension period of the appellant (i.e. 29.07.2016 to 24.08.2016) was ordered to be treated as leave of kind due. The appellant in his Departmental appeal pleaded that the Inquiry Officer in his case vide its enquiry report dated 14.12.2016 has reported that no charge stands proved against him still the competent Disciplinary Authority has ordered the suspension period (i.e. 29.07.2016 to 24.08.2016) as leave of kind due and further requested that the appeal may kindly be considered as per Rule.

Considering the contents of appeal, an opportunity of personal hearing has been granted to appellant on 10.11.2017. He appeared in person and reiterated the contents of appeal. Besides this, he produced no other relevant evidence or documentary proof.

Perusing the contents of appeal and facts available on file, I found that the appellant was served charge sheet on account of creating indiscipline and forming groups among staff. He has also charged with not writing daily diary and not getting the daily diary checked from competent authority, which I think is a serious misconduct. A teacher is a noble profession and students always obey the trend fixed by them. If a teacher creates indiscipline in the school and does not obey the order of his immediate Head then his disciples would be adversely affected. Such a teacher is not entitled to any leniency.

After considering all facts, I am of the considered view that the Disciplinary Authority has taken a lenient view while deciding the suspension period as leave of kind due. I found that the teacher himself is responsible for his suspension. I found no abnormality in the Disciplinary Authority order, accordingly, the appeal preferred is found devoid of merits. No injustice has come into light. I reject the appeal and keep the order of Disciplinary Authority intact.

I pass order accordingly.
