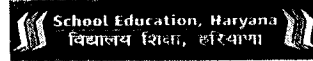

ORDER

Memo No. 17/22-2014 PS(3)

Dated, Panchkula : 30-3-2017

Whereas Saraswati Sports School Madlauda, Panipat was granted provisional recognition for class **1st to 8th** w.e.f. from 01.04.2015 run by managing committee Bhalla Ram Education Trust, Kavi Road, Madlauda, Panipat vide order no. 17/1-2014 PS (3) dated 07.12.2015 by the Directorate of Elementary Education Haryana, Panchkula.

Whereas, a complaint was made to the District Town Planner (Enforcement) Panipat by Shri Mahavir Singh S/o Sh. Ram Chander, R/o Panipat, informing that the provisional recognition to the said school of the Trust had been granted on the basis of NOC dated 23.06.2014 issued by District Town Planner (Enforcement) Panipat. The said NOC bearing memo no. 4236 dated 23.06.2014 was examined by the District Town Planner and found that no such NOC was granted to the said Trust by that office.

Whereas, District Town Planner (Enforcement), Panipat vide his memo no. PT/DTP (D) 2574/complaint, dated 26.08.2016 has intimated that the land of Bhalla Ram Education Trust, Kavi Road, Madlauda, Distrcit Panipat falls in the controlled area, Madlauda which was notified on 22.04.2010. In the controlled area school building cannot be constructed without obtaining change of land use permission (CLU) from the Director General, Town & Country Planning Haryana, Chandigarh. Further, there is no provision to issue NOC in the controlled area for erection/re-erection of building. Resultantly, FIR No. 227 dated 30.06.2016 U/s 3/6/7PSR of CAR of UDAS 1963 and FIR No. 335 dated 14.09.2016 U/s 420 of IPC at Police Station Matlauda (Panipat) was got registered by District Town Planner against the office bearers of the Trust. The matter against the Trust is still pending before the Trial Court, Panipat.

On the basis of the aforesaid recommendation of District Town Planner (Enforcement), Panipat, a notice of showing cause was issued on 30.09.2016 to the Trust as to why the provisional recognition granted to their

school namely Saraswati Sports School Madlauda, Panipat may not be withdrawn w.e.f. the academic session 2017-18. The Trust was also granted 15 days time from the receipt of communication to submit reply to the notice. No reply was submitted by the Trust within the stipulated period. Thereafter, on 25.10.2016, a reminder was also given to the Trust. Ultimately, the trust submitted its reply to the Show Cause Notice which was received in the Department on 16.11.2016. In the reply, the Vice Chairman of the Trust submitted that no responsible person of the Trust has even forged any NOC nor obtained or knowingly used or submitted any such forged document and the Trust has been falsely involved in the matter. It was also submitted by him that the matter is sub-judice before the Trial Court and requested not to withdraw the recognition of the school at this stage.

Thereafter, the Trust also submitted reply dated 02.02.2017 to the notice dated 30.09.2016 almost reiterating the same version of the earlier reply. The Chairman of the Trust in reply dated 02.02.2017 submitted that when they come to know that the area of Madlauda has been notified as controlled area vide notification dated 22.04.2010, they immediately applied on 27.05.2016 to the Director General Town and Country Planning for obtaining CLU alongwith requisite fee. The Trust also submitted that approximately 400 students are taking education in their school and if the recognition is withdrawn by the Department the student studying in the school would suffer an irreparable loss.

The Trust was also granted opportunities of personal hearing in accordance with rules. During the course of hearing today, the counsel for the Trust reiterated the same version as mentioned in the earlier replies of the Trust and submitted that the Trust undertakes to submit the CLU within two weeks and recognition of the school may not be withdrawn in the interest of the students studying in the school.


After hearing the rival contention of the parties, I have come to the conclusion that the areas of Madlauda had been notified in the controlled area a way back in 2010 and the Trust was very much aware about this fact,



though, the Trust submitted a fake NOC instead of CLU which was not required in controlled area and succeeded in getting the permanent recognition of their school by misleading the Department. Apart from the above, after perusal letter dated 26.08.2016 of District Town Planner (Enforcement) Panipat addressed to Director General Elementary Education Haryana, it has to come notice that a Show Cause Notice was issued to the Trust by that Department vide memo no. 2385/complaint dated 12.08.2016 with a request to give reply within 7 days but till date no reply has been submitted by the Trust to that show cause notice. This contention of the Trust is of no use as the DTP (P) Panipat, vide their letter no. 667/CLU-770 dated 21.03.2017, has informed this Department that case of the Trust for grant of CLU permission has been rejected by their office. Thus, there is no force in the contentions raised by the Trust which can substantiate their claim. Besides, the Trust has failed to submit any such document on the basis of which some relief could be granted to it. Hence, the recognition granted to the school of the Trust is liable to be withdrawn w.e.f. the next academic session i.e. 2017-18 which is commencing w.e.f. 01.04.2017. The school management is directed not to make any admission for the next academic session i.e. 2017-18 and adjust the students already admitted by them in the nearby Govt. or private schools.

As a sequel of above findings, the recognition of the school of the Trust namely Saraswati Sports School Madlauda, Panipat is hereby withdrawn w.e.f. next academic session i.e. 2017-18.

I pass the order accordingly.
