



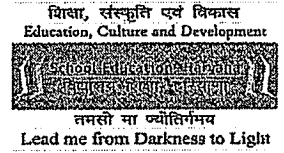

Whereas, Shri Ram Chander Jhangra [009712] the then Principal, Government Senior Secondary School, Jhumpa Khurd [536] now posted at Block Education Officer Sadhaura [5018], Yamuna Nagar was charge-sheeted under rule-7 of the Haryana Civil Services (P&A) Rules 1987 vide order dated 17.01.2015 and the following allegation was leveled against him.

"That one Sh. Rohtash S/o Sh. Ram Swarup, R/o Village Jhumpa Khurd, District Bhiwani filed CWP No. 17516 of 2012, praying therein that he had applied for the post of part-time sweeper in GPS Madhopura on 03.11.2006 and he i.e. Sh. Ram Chander Jangra in connivance with Sh. Rohtash, S/o Ram Swarup, R/o Village Atela Khurd issued an appointment letter dated 29.02.2008 in place of him i.e. actual applicant to another one Sh. Rohtash S/o Sh. Ram Swarup, R/o Village Atela Khurd. Hon'ble High Court disposed of the said writ petition vide order dated 07.09.2012 to decide the representation of petitioner to be submitted. On deciding the same, the department vide order dated 23.11.2012 found that wrong person has been joined by Sh. Ram Chander Jangra in place of the actual applicant and accordingly directed to remove Sh. Rohtash S/o Sh. Ram Swarup R/o Village Atela Khurd and also ordered to recover the amount from him i.e. Sh. Ram Chander Jangra paid to the wrong person. A FIR No. 181, dated 12.09.2012 under sections 420, 427, 467, 468, 120-b IPC, PS Siwani was also registered against him i.e. Sh. Ram Chander Jangra. Thus, he caused a loss of Rs. 85,200/- to the State Exchequer, which is liable to be recovered from him".

Shri Ram Chander Jhangra furnished his reply to the charge sheet on 13.02.015 and denied all the charges levelled against him. He submitted in his reply stating therein that Sh Rohtash S/o Shri Ramswaroop, VPO Atela Khurd was appointed as sweeper by Block Education Officer, Siwani and the appointment letter was also dispatched by Block Education officer, Siwani vide letter no 1353-54 dated 29.02.2008. Thus, the allegation of appointment of Sh Rohtash W/o Shri Ram Swaroop as sweeper is devoid of merit. Finding his reply unsatisfactory, Shri R P Bhasin, District & Session Judge (Retd) was appointed as an Inquiry Officer on 29.07.2016 to conduct regular departmental enquiry on the charges levelled against Shri Ram Chander Jhangra. The Inquiry Officer submitted his report on 02.09.2016 and concluded that the charges stood proved against the delinquent. Thereafter, he was afforded an opportunity of personal hearing on 24.07.2017. During the course of hearing, he reiterated the facts submitted by him in his earlier reply.

On the basis of report of Inquiry Officer dated 02.09.2016 and submission made by the delinquent during personal hearing, I inflict punishment of stoppage of two annual increment without cumulative effect on him.


