
Whereas in pursuance of interim order dated 03.11.2016 in LPA No.1035 of 2015 - Manish Kumar & Others V/s HSSC & Others, the Assistant Education Officer, Sports O/o. District Education Officer, Sonapat was directed to appear before Hon'ble High Court on 23.03.2017 with relevant record on basis of which an experience certificate was issued in favour of Sh.Vishnu S/o. Sh.Chand Ram, VPO Khidwali, Distt. Rohtak.

No person appeared before Hon'ble High Court on the date fixed i.e. 23.03.2017. Consequently the Hon'ble High Court took strict view and ordered Director School Education, Haryana to appear before Hon'ble High Court. Therefore, cognizance of the case has been taken and Sh.Sewa Ram, AEO has been served upon a charge sheet vide order dated under Rule-7 on grounds of non-compliance of Hon'ble High Court order dated 03.11.2016. He submitted his reply on 29.08.2017 but not finding the reply satisfactory, Sh. D.D.Gautam, IAS (Retd.) was appointed Inquiry Officer vide order dated 21.01.2018. He issued notice to delinquent i.e. Sh. Sewa Ram to appear and attend the enquiry.

After due process of enquiry, the Inquiry Officer submitted its report dated 15.04.2018 stating therein that the charges leveled upon Sh.Sewa Ram, AEO vide charge sheet dated 08.08.2017 are not proved as the Hon'ble High Court vide its order dated 03.11.2016 has ordered the AEO who was in working on 08.05.2010 when the experience certificate was issued. Since, Sh.Sewa Ram joined as AEO in the office of DEO, Sonapat on 30.09.2016, therefore, he is not responsible for non appearance before Hon'ble High Court on 23.03.2017.

I considered the orders of Hon'ble High Court with record on file and the enquiry report submitted by the Inquiry Officer, I am fully agreed with the report of the Inquiry Officer. No further action is required in the present case. Consequently the charge sheet issued upon Sh.Sewa Ram is hereby dropped and the case is filed accordingly.



Sonapat to change the option for the medical reimbursement from fix medical allowance to open medical allowance facility w.e.f. 01.04.2018 in terms of Haryana Government instructions issued from time to time on the following conditions:-

1. That he/she shall not be entitled for fixed medical allowance w.e.f. 01.04.2018 the date of option change and the fixed allowance, if any amount paid to him/her after date of change of option will have to be deposited in Government Treasury.
2. The reimbursement will be made only for chronic diseases declared by Haryana Govt. from time to time.
3. That he/she shall not be entitled for fixed medical allowance as long as he avails open medical allowance facility.
4. That the medical option has been changed since the employ/employee's dependent family member is suffering from chronic disease. The certificate in this regard should be issued by the competent authority defined in the Rules.
5. The Medical Certificate is to be reviewed/renewed after a period of two years or before date of its expiry whichever is earlier otherwise his/her medical option will be changed from open to fixed automatically
