
Whereas an FIR No.59 dated 27.04.2005 u/s 306, 34 IPC was registered at Police Station Bawani Khera against Sh. Sajjan Kumar alias Sajjan Singh S/o. Sh. Om Parkash, Math Master, GSSS Bawani Khera Distt. Bhiwani. He was arrested on 25.09.2005 and put in judicial custody, resultantly thereon, he was put under suspension vide this Directorate Order dated 29.10.2005 w.e.f. the date he was arrested i.e. 25.09.2005.

After due consideration of facts and circumstances, Hon'ble Additional Sessions Judge, Bhiwani vide its order dated 24.01.2008 imposed a punishment of rigorous imprisonment for a period of 5 years and to pay a fine of Rs.5000/- on the convicted i.e. Sh.Sajjan Kumar. He preferred a criminal appeal i.e. No. 166 SB of 2008 with Criminal Misc. Application No.51897 of 2008 before Hon'ble High Court at Chandigarh but the conviction has been kept intact only the sentence has been suspended during the pendency of the appeal. The Criminal Appeal is still pending.

Since, the concerned Math Master has been declared convicted and ordered to undergo imprisonment for 5 years resultantly thereon, his services deserves to be dismissed on conviction in pursuance of Punjab Govt. Circular No. 4819-G-II-57/11919 dated 08.07.1957 but before issuing order of dismissal, it has been considered that an opportunity to defend itself be awarded to convicted Math Master under the principles of natural justice with liberty to put forth all his documentary defense.

Considering all the contents on file and the judgment passed by Hon'ble Additional Sessions Judge, Bhiwani, I being competent Disciplinary Authority grant an opportunity to Sh. Sajjan Kumar S/o. Sh. Om Parkash, Math Master, GSSS Bawani Khera Distt. Bhiwani with liberty to put forth all his documentary defense in his favour within 15 days of issuance of this order, otherwise it would be presumed that the convicted has no defense to put forth and an ex-parte order of dismissal from services would be passed.




