 - (ii) no child shall be subjected to physical punishment or mental harassment;
 - (iii) no child is required to pass any board examination till the completion of elementary education.



Whereas the delinquent i.e. Smt. Anju Arora (Id.011125), TGT (Maths), GHS Garhi Bazidpur now at GSSS Makdola Distt. Gurugram was served chargesheet under rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 vide this Directorate Order dated 29.07.2015 stating therein 5 charges including charge of long absence from duty and forging record of EOL in school order book and service book. In the meantime she filed a civil suit before Hon'ble Civil Suit at Gurugram to put the enquiry at halt. In her reply, the delinquent refuted all the charges. The reply submitted by the delinquent has not been found satisfactory thereafter, Sh. V.P.Batra IAS (Retd.) has been appointed inquiry officer to conduct a regular enquiry under the principles of natural justice.

The delinquent duly participated the enquiry process on completion of enquiry process, the inquiry officer submitted its report dated 13.11.2016 which was duly supply to her to comment thereon. She submitted her comments which received in this directorate on 20.04.2017 praying therein that the charges level upon him be dropped and her application for voluntary retirement be allowed. Thereafter, the competent disciplinary authority granted her the opportunity of personal hearing 30.05.2017 and 15.11.2017 but she never turned up.

Considering all fact on file and enquiry report, thereafter finding that the delinquent is habitual of remaining absent from duty which not only affects the study of the students but also affects the administration, therefore, I am of the considered view that the delinquent does not want to serve the State and willingly remains absent from duty but before taking final decision herein, I am of the view that the delinquent be granted another opportunity of personal hearing why the punishment of dismissal from service be not awarded upon her. The delinquent is granted opportunity to reply this show cause notice within a period of 15 days, otherwise further action would be taken ex parte.


