


Whereas the Appellant i.e. Smt. Kaushalya Gupta, TGT (SS) GSSS Jhumpa Khurd (Bhiwani) now posted at GHS Uklana Gaon (Hisar) has preferred an appeal against order dated 25.07.2017 passed by Disciplinary Authority i.e. Additional Director Administration vide which the suspension period of the Appellant was ordered to be considered as leave of kind due.
