4. For the children referred to in paragraph 3, the school shall be reimbursed as per sub section (2) of section 12. To receive such reimbursements school shall provide a separate bank account.
5. The school shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
6. The school shall not deny admission to any child for lack of age proof. If such admission is sought subsequent to the extended period specified for admission, the same shall not be denied and the child shall not be discriminated on the ground of religion, caste or race, place of birth or any of them.

The school shall ensure that :-

- (i) no child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;
 - (ii) no child shall be subjected to physical punishment or mental harassment;
 - (iii) no child is required to pass any board examination till the completion of elementary education.
 - (iv) every child completing elementary education shall be awarded a certificate as laid down under rule 22;
 - (v) inclusion of students with disabilities /special needs as per provision of the Act;
 - (vi) the teachers are recruited with minimum qualifications as laid under section 23(1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualification within a period of 5 years;
 - (vii) the teacher performs its duties specified under section 24(1) of the Act; and
 - (viii) the teachers shall not engage himself or herself for private teaching activities.
7. The school shall follow the syllabus on the basis of curriculum laid down by academic authority.
 8. The school shall enroll students proportionate to the facilities available in the school as prescribed 19.
 9. The school shall maintain the standards and norms of the school as specified in section 19 of the Act.

- 12.The school is run by a society registered under the Societies Registration Act, 1860(21 of 1860), or a public trust constituted under any law for the time being in force.
- 13.The accounts should be audited and certified by a Chartered Accountant and proper accounts statement should be prepared as per rules. A copy each of the statements of accounts should be sent to the District Elementary Education Officers every year.
- 14.The recognition code Number allotted to your school is **3645/BWN/5th/BOSE/2018**. This may please be noted and quoted for any correspondence with this office.
- 15.The school furnishes such reports and information as may be required by the Director of Education/District Elementary Education Officer from time to time and complies with such instructions of the State Government/Local Authority as may be issued to secure the continued fulfilment of the condition or recognition or the deficiencies in working of the school.
- 16.Renewal of Registration of Society, If any be ensured.
- 17.Other Condition as per Annexure III.

Whereas Sh. Parmanand, TGT (SS) got fabricated false transfer order i.e. 2/365-03-E-IV (3) dated 14.11.2003 from GSSS Jharsa, Gurgaon to GSSS Rajjipur Panchkula and joined at GSSS Rajjipur on the post of Lecturer in English. He performed duties as Lecturer English from 20.11.2003 to 15.05.2004. Thereafter, an FIR (i.e. No. 30 dated 02.03.2004) was registered at Police Station Naraingarh and under the offence of fraud and forgery he was arrested on 29.05.2004 and thereafter put under deemed suspension from the date of arrest vide this Directorate order dated 15.02.2005.


The appellant was also served a charge sheet under Rule 7 of HCS (P&A) Rules, 1987 and getting the reply unsatisfactory Sh. D.D. Gautam, IAS Retd. was appointed Inquiry Officer. In his enquiry report, the enquiry officer concluded that the charges leveled upon the delinquent stands proved. After due process a punishment of stoppage of four increments with cumulative effect was inflicted upon him.

The appellant preferred an appeal before 1st Appellate Authority under services rules 2012 i.e. Director Elementary Education, Haryana praying therein to remit or commute the penalty. He was heard and the punishment has been modified upto stoppage of one increment without cumulative effect. It means the appellant is still found responsible for the mis conduct of joining on the post of Lecturer in English whereas in actual he was a TGT (SS).

Through the present appeal, the appellant has prayed for payment of balance of pay of suspension period. He granted an opportunity of hearing with liberty to put his locus standi for the arrears of balance of pay on 23.04.2018. The appellant appeared in person and heard. He failed to prove that he has not committed any mis conduct and he is innocent. He admitted that he has served on post of Lecturer in English while his service as TGT (SS) on basis of fabricated transfer order. He also admitted that he has still been inflicted with punishment of stoppage of one increment without cumulative effect.

Considering all the facts on file and admission of the appellant, I found no merit in this appeal and the same is hereby rejected with specific order that the suspension period is restricted upto the subsistence allowance already paid to him. However, the suspension period be counted as duty period for the purpose of pension only.

Ordered accordingly.



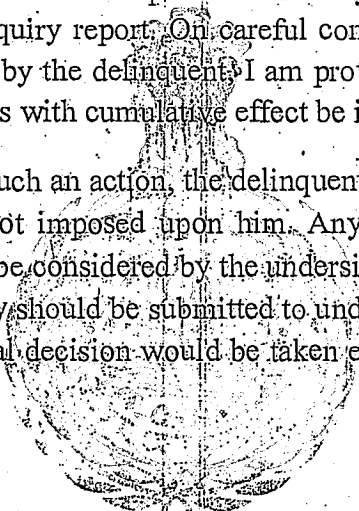

Whereas a complaint dated 30.03.2016 was received against the delinquent i.e. Manish Kumar, TGT (SS), GMS Lottan now at GGSSS Nariangarh Distt. Ambala. A preliminary enquiry was conducted by Block Education Officer Nariangarh and the same was submitted to this directorate vide letter dated 20.05.2016 and it has been found that the delinquent studied two courses i.e. D.Ed. and B.A. on the same time. A show cause notice was served upon delinquent vide this directorate letter dated 26.08.2016 and the same was replied by the delinquent on 08.09.2016 refuting all the charges leveled upon him. A charge sheet dated 26.08.2016 was also served upon delinquent. Thereafter, Sh. R.P. Bhasin District & Sessions Judge (Retd.) was appointed as Inquiry Officer vide order dated 04.11.2016. He submitted his ex-parte inquiry report dated 29.11.2016 stating therein that totality of the evidence on record shows that the delinquent has acted in a manner unbecoming of an official of the Education Department. Thereafter, on request of the delinquent Sh. R.P. Bhasin Supra reopened the enquiry in pursuance of this office letter dated 28.03.2017 and again submitted his report 11.08.2017 stating that the charges leveled upon the delinquent stood fully proved.

Thereafter enquiry report was forwarded to delinquent vide this directorate letter dated 08.09.2017 for submitting defence within a period of 30 days. The delinquent submitted his reply dated 17.04.2018 refuting the enquiry report. On careful consideration of contents on file, enquiry report and the defence submitted by the delinquent, I am provisionally of the view that a penalty of stoppage of two annual increments with cumulative effect be imposed on delinquent.

However, before taking such an action, the delinquent is given an opportunity to show cause as to why the said penalty be not imposed upon him. Any representation which he may like to submit in this connection, would be considered by the undersigned before taking final decision in the matter. Such representation, if any should be submitted to undersigned with 15 days of receipt of this communication failing which final decision would be taken ex parte. No further opportunity would be granted.
