Whereas Sh. Mahender Singh S/o Sh. Suraj Bhan, SS Master (Retd.) Govt. High School Manuwas Distt. Mewat approached Hon'ble Punjab & Haryana High Court Chandigarh by way of filing present writ petition i.e. CWP No. 20698 of 2017 – Mahender Singh V/s State of Haryana & others praying therein for a writ in the nature of mandamus directing the respondents to grant them benefit of 2<sup>nd</sup> ACP Pay Scale on completion of 16 years regular satisfactory service. He also got served a legal notice dated 25.05.2017 upon respondents, but in vain.

The writ petition came for hearing before Hon'ble Court on 13.09.2017 and the Hon'ble Court pleased to dispose of the writ petition with directions as under:-

*“Instant petition is disposed of with a direction to respondent no. 2-Director Secondary Education Haryana, 30 Bays Building, Sector-17, Chandigarh to look into the grievances unfolded by the petitioner in his legal notice dated May 25, 2017 (Annexure P-3) and take a conscious decision by passing a speaking order according to rules and instructions particularly in view of notification dated March 04, 2014 (P-1) and another notification dated August 25, 2014 (P-2) issued by Finance Department, Government of Haryana within a period of three months from the date of receipt of a certified copy of this order.”*

In pursuance of these directions the legal notice dated 25.05.2017 has been considered and it has been found that the petitioner was engaged as SS Master by the local authorities in the year 1986 and he joined the School Education Department on adhoc basis on 26.12.1986. His services were regularized w.e.f. 01.01.1991 as per pay scale sanctioned by Finance Department, Government of Haryana time to time. It has also been found that he is an employee of Elementary Education Department Haryana therefore, he has impleaded Director Secondary Education Haryana wrongly.

Further, it has been found that the petitioner attained his age of superannuation i.e. 58 years on 10.07.2010, resultantly thereon, he was retired from service on 31.07.2010 after completing 19 years 7 months regular service, it means he never completed 20 years of regular satisfactory service before his retirement as required by Haryana Civil Services (ACP) Rules, 2008. The relevant and operative part of these Rules, 2008 is reproduced as under:-

*“7. Eligibility for Grant of ACP grade Pay under the general ACP scheme:— (1) Every Government servant covered under the general ACP scheme shall, for the purposes of drawal of pay, be eligible for the first ACP grade pay (given in column 4 of Part II of Schedule I in respect of the functional pay scale or pay structure of his post) if **he has completed 10 years of regular satisfactory service and has not got any financial upgradation in these ten years with reference to the functional pay structure of the post to which he was recruited as a direct entrant.** Financial upgradation in this context includes functional promotion in the hierarchy or further revision/ modification of the pay structure for the same post after 1.1.2006.*

(2) Every Government servant covered under the general ACP scheme shall, for the purposes of drawal of pay, be eligible for the second ACP grade pay (given in column 5 of Part II of Schedule I in respect of **the functional pay scale or pay structure of his post**) **if he has completed 20 years of regular satisfactory service and has not got any financial upgradation in the last ten years.** Financial upgradation in this context includes functional promotion in the hierarchy or further revision/ modification of the pay structure for the same post after 1.1.2006.

(3) Every Government servant covered under the general ACP scheme shall, for the purposes of drawal of pay, be eligible for the third ACP grade pay (given in column 6 of Part II of Schedule I in respect of the functional pay scale or pay structure of his post) if he has completed 30 years of regular satisfactory service and has not got any financial upgradation in the last ten years and has not got more than two financial upgradation so far. Financial upgradation in this context includes functional promotion in the hierarchy or further revision/ modification of the pay structure for the same post after 1.1.2006.

(4) In case of a Government servant who gets promoted, he will be considered for the next ACP grade pay after he completes 10 years of regular satisfactory service in the promotional post without any financial upgradation and will be entitled to the next ACP grade pay with reference to the grade pay of the promotional post he holds :

Provided that a Government servant shall not be entitled to avail ACP upgradation if, he has already availed of three financial upgradation of any kind in his career.

Note.— For the purpose of these rules, **“regular satisfactory service” means continuous service counting towards seniority under Haryana Government, including continuous service in Punjab Government before re-organization, commencing from the date on which the Government servant joined his service after being recruited through the prescribed procedure or rules etc.** for regular recruitment, in the cadre in which he is working at the time of being considered his eligibility for grant of ACP pay band and grade pay under these rules and further fulfilling all the requirements prescribed for determining the suitability of grant of ACP pay structure.”

It has also been found after observation of service record that the petitioner has already been granted benefit of 1<sup>st</sup> ACP pay scale of Rs. 6500-9900 w.e.f. 01.01.2001 by this Department vide District Education Officer, Gurgaon vide order no. E-II/2001/540-46 dated 10.05.2001. Since, the petitioner has never completed 20 years of regular satisfactory service as required under rule 7(2) (Supra), he is not found entitled to claim benefit of 2<sup>nd</sup> ACP Pay scale.

It is also relevant to state that the Finance Department Haryana issued Order No. 1/83/2008-1PR(FD) dated 04.03.2014 to modify the ACP Pay Grade Structure and length of regular satisfactory service for granting of ACP benefits. The petitioner has not considered the contents of para no. 5 of this order in which the position has already been clarified by the Finance Department itself. This para says as under:-

**“5. These orders shall be applicable with immediate effect i.e. w.e.f. issuance of these orders. In such cases where ACP has already been granted, the existing ACP Grade Pay shall be replaced with modified ACP Grade Pay without the benefit of increment. Other terms and**


*conditions for grant of ACP Grade Pay and fixation of pay therein shall remain unchanged."*

It is crystal clear from above said para that the order dated 04.03.2014 has been made effective from 04.03.2014. The petitioner got retirement on 31.07.2010 on attaining the age of superannuation i.e. 58 years, therefore, it cannot be presumed by him that this order is applicable in his case. Moreover, the position has already been clarified by Hon'ble High Court in CWP No. 17496 of 2014- Om Parkash & others V/s State of Haryana & others, decided on 18.03.2017 in which the Hon'ble Court has observed that the benefit granted vide order dated 04.03.2014 cannot be granted retrospectively.

Still, the petitioner has been granted opportunity of personal hearing with liberty to put forth all relevant rules or documents in his favour. The petitioner appeared on 18.06.2018 and heard but he failed to refute the action of the respondents vide which the benefit of 2<sup>nd</sup> ACP Pay Scale was denied to him.

Considering all the factual position and statutory financial rules as issued by Finance Department Haryana time to time, it can be concluded that no injustice has been done with the petitioner and there is no illegality in not granting him benefit of 2<sup>nd</sup> ACP Pay Scale. I found the legal notice dated 25.05.2017 devoid of merits, consequently, the relief claimed therein is denied.

I order accordingly.
