Whereas Sh. Harender Singh, SS Master, Govt. Middle School Bass Mohalla, Palwal was put under suspension vide order dated 06.05.2014 by specific order of W/Principal, Secretary, School Education, Haryana as it was then. Smt. Santosh Kumari, Assistant Director was appointed as Inquiry Officer to conduct preliminary enquiry. She called the delinquent on two occasions but he did not turn up knowingly. He has been served a chargesheet under Rule-7 of HCS (Punishment & Appeal) Rules, 1987 vide order dated 22.09.2015. Thereafter, Sh. D.D. Gautam, IAS (Retd.) has been appointed Inquiry Officer. He reported on 07.12.2016 observing therein that the charges leveled upon the delinquent stand proved as delinquent never remained posted as ABRC at Block Palwal, District Palwal. The enquiry report has duly been served upon him as per rule. The delinquent refuted the enquiry report stating that the complaint has been made under rivalry. He requested for dropping of charge sheet. Considering, all facts and circumstances of the case, an opportunity of personal hearing has been granted to him on 16.03.2018.

He appeared in person and heard. He made verbal submissions during personal hearing but failed to submit concrete proof in his defense. Considering all the facts of the matter, I am satisfied with the report of Inquiry Officer. I am of the considered view that the delinquent deserves to be punished, accordingly, a Show Cause Notice under the principles of natural justice to award a punishment of stoppage of one increment with cumulative effect upon the delinquent has been issued. However, he has been granted an opportunity to reply the Show Cause Notice within 15 days.

The delinquent submitted his representation dated 30.04.2018 and an opportunity of personal hearing granted to him on 22.10.2018.

The delinquent heard in person during personal hearing on 22.10.2018 but he failed to refute the charges leveled against him in the charge sheet. Still a lenient view has been taken and the punishment of stoppage of one increment without cumulative effect is imposed upon Sh. Harender Singh, SS Master and suspension period be treated as leave of kind due for all purposes.
