



SS Mistress, GSSS Shahpur (Ambala)** to change the option for the medical reimbursement from **fix medical allowance to open medical allowance** facility for reimbursement of outdoor expenses of allopathic treatment of chronic disease(s) **w.e.f. 27.03.2018** in terms of Haryana Government instructions issued from time to time on the following conditions:-


1. That he/she will not be entitled fix medical allowance w.e.f. **27.03.2018**, if any, paid to his/her after the date of change of option will have to be deposited in Government Treasury.
2. That he/she will not be entitled fix medical allowance until he/she avails open medical allowance facility.
3. That the option has been changed since the **employee's daughter** is suffering from chronic disease. The certificate in this regard has been issued by **PGIMER Chandigarh vide no. Tx. Surg. 2018/106 dated 27.03.2018**.
4. The Medical Certificate is to be reviewed/renewed after a period of two years or before date of its expiry whichever is earlier otherwise his/her medical option will be changed from open to fix automatically.
5. The reimbursement will be made only for chronic diseases declared by Haryana Govt. from time to time.

Whereas the petitioner Smt. Pushpa filed CWP No. 14750 of 2018 in the Hon'ble High Court, which came up for hearing on 01.06.2018 and was disposed of and the following order was passed:-

"The petitioner is employed as a Guest Faculty Teacher. Her grievance is that a representation dated 15.02.2018 (Annexure P-5) has been made for extension of her tenure but no order has been passed thereupon till date.

Notice of motion.

Mr. Rajesh Gaur, Addl. A.G., Haryana, accepts notice on behalf of respondents. Let six copies of the complete paperbook be supplied to him during the course of the day. In view of the nature of the order being passed, there is no need to seek written statement.

The writ petition is disposed of with direction to respondent No.2, to objectively consider the representation dated 15.02.2018 (Annexure P-5), by passing a speaking order thereupon, within a period of four weeks from the date of receipt of a certified copy of this order."

Whereas the copy of the order dated 01.06.2018 was received in this office from the Office of Advocate General, Haryana on 15.06.2018 and certified copy of the order dated 01.06.2018 was received in this office on 05.07.2018 from Assistant Registrar (WRITS) High Court of Punjab and Haryana, Chandigarh. After the receipt of the order dated 01.06.2018 of the Hon'ble High Court and in compliance of the same the representation dated 15.02.2018 (Annexure P-5) of the petitioner Smt. Pushpa was perused. In the representation Smt. Pushpa submitted that she is posted as Guest Faculty Teacher on the post of JBT at Govt. Primary School, Rahra (Karnal) with the school code 13953 provided by the department. Her service tenure will be completed on 31 August 2018. She further submitted that she is a widow having three children and have no additional source of income beside this. She requested that she may kindly be granted extension in service according to rules so that her family's expenditure run smoothly.

Whereas, in compliance of order dated 01.06.2018 of Hon'ble Court, the representation of the petitioner has been considered. It is an admitted fact that the petitioner Smt. Pushpa is not a Govt. employee and statutory provision of the service rules governing the service of the Govt. employee cannot be applicable in

the case of the petitioner being a Guest Teacher working on contract basis. Services of Guest Teachers are governed by the policy/guidelines issued from time to time and do not provide extension of service of Guest Teacher beyond 58 years. In view of this, the case of the petitioner Smt. Pushpa was liable to be declined. Still in the interest of justice, she has been granted opportunity of personal hearing on 13.07.2018 with liberty to submit relevant documents in her favour. She appeared in person on 13.07.2018 before the undersigned but could not submit any documents which may entitle her for extension in service. No document has been submitted by the petitioner.

Whereas, after hearing the petitioner, Smt. Pushpa and considering all relevant document, I am of the considered view that she is not entitled for extension in service beyond 58 years. Accordingly the claim sought by the petitioner through representation dated 15.02.2018 is hereby declined.
