3. The school shall admit in class I, to the extent of the Strength of that class. Children belonging to weaker section and disadvantaged group in the neighbourhood and provide free and compulsory elementary education till its completion:





SHOW CAUSE NOTICE

ORDER NO. 15/140-2013 HRM-I(4)

Dated Panchkula, the 30.05.2018

Whereas a complaint dated 03.06.2013 against Sh. Harender Singh, SS Master, Govt. Middle School Bass Mohalla, Palwal was received from BEO Palwal and on the basis of which he has been served a chargesheet under Rule-7 of HCS (Punishment & Appeal) Rules, 1987 vide order dated 05.06.2015. Thereafter, Sh. D.D. Gautam, IAS (Retd.) has been appointed Inquiry Officer. He reported on 09.02.2018 observing therein that the charges leveled upon the delinquent stand proved as delinquent proceeded to perform exam duties from time to time willfully and without approval of the competent authority. The enquiry report has duly been served upon him as per rule. The delinquent refuted the enquiry report stating that he performed such duties within the knowledge of School Incharge. He requested for dropping of charge sheet.

He made written submissions in his defence reply but failed to submit concrete proof in his defense. Considering all the facts of the matter, I am satisfied with the report of Inquiry Officer. I am of the considered view that the delinquent deserves to be punished, accordingly, the delinquent deserves to be issued a Show Cause Notice under the principles of natural justice before imposing of punishment. Hence a Show Cause Notice to award a punishment of stoppage of two increments without cumulative effect is served upon delinquent. However, he is granted opportunity to reply the Show Cause Notice within 15 days. It is also made clear, if the delinquent fails to submit its reply within stipulated time period, ex parte decision would be taken.
