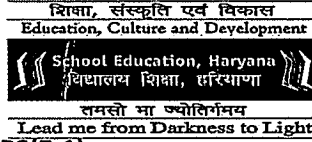



Whereas the petitioner i.e. Subhash Chander approached Hon'ble High Court by way of filing CWP No. 15857 of 2013 – Subhash Chander Vs. State of Haryana praying therein quashing of order dated 30.10.2012 (Annexure P-1) vide which the benefit of counting of sanctioned post service rendered at Gurukul Arya Nagar Hisar, a government aided privately managed school towards pensionary benefits of the petitioner has been declined. The Hon'ble High Court vide judgement dated 30.08.2017 quashed the order dated 30.10.2012 (Annexure P-1) and allowed the writ petition by passing the following order/direction :-

"Both learned counsel are ad idem that though the petitioner is not entitled to any pension, he having joined even a Government Aided School in the year 2008, prior to his joining Government service, in the year 2011, with the pension scheme having been wholly changed w.e.f. 01.01.2006, however, learned counsel for the petitioner submits that the petitioners' only grievance is that the amount deducted/paid by him towards the contributory provident fund while he was in service in the Gurukul Aryanagar School, District Hisar (respondent no. 3), be also allowed to be deposited by him towards benefit in the pensionary scheme now applicable to him in Government.


The aforesaid prayer is considered reasonable and this petition is therefore disposed of with a direction to the respondents to allow the petitioner to deposit with the Government, the amount paid by him/deposited on his behalf towards the contributory provident fund scheme while he was working in the Gurukul Aryanagar School, District Hisar, so as to enable him to draw benefit thereof in the pensionary scheme now applicable to him."

On getting the certified copy of the judgment dated 30.08.2017, the service record of Sh. Subhash Chander has been re-considered in light of Finance Department Haryana Govt. Notification No. 1/1/2004-1 Pension dated 28.10.2005 and the advice tendered vide U.O. No. 60/20/10/FD-II/87-A dated 31.05.2011. It has been found that the petitioner joined services on the sanctioned post of Science Master at Gurukul Arya Nagar Hisar in February, 2008 and on getting appointment letter from School Education Department Haryana joined this department on 18.04.2011, on the post of Math Master. A perusal of these joining would make clear that the petitioner Sh. Subhash Chander joined services when the rules provided under Punjab Civil Services Rules, Vol-II and Haryana Aided Schools (Special Pension & Contributory Provident Fund) Rules, 2001 (Dated: 29.03.2001) were not applicable. Hence, the old pension rules were not applicable in his case. On this issue, Ld. Counsels to both parties were ad idem.

It has also been considered that the services of Sh.Subhash Chander at Gurukul Arya Nagar Hisar as well as under Elementary Education Department Haryana are covered under New Pension Scheme. The Hon'ble High Court has also considered this fact and allowed the writ petition with directions to respondents to allow the petitioner to refund or deposit the employer share of CPF with compound interest thereon @ 10% p.a. to Government of Haryana to get counted his service at Gurukul Arya Nagar Hisar towards pension and gratuity.

After due consideration of facts of service as well as advice of the Audit Cell of the Department, I found that the claim of Sh. Subhash Chander to get his service (18.02.2008 to 17.04.2011) which he rendered at Gurukul Arya Nagar Hisar is tenable and countable as qualifying service under rules towards retiral benefits under New Pension Scheme subject to condition that he would refund or deposit the employer share of CPF with compound interest @10% per annum in Government Treasury of service which he rendered on sanctioned post at Gurukul Arya Nagar Hisar (i.e. Privately Managed Government Aided School) to Govt. Haryana.

I pass order accordingly.




