



Whereas Sh. Raj Bal, SS Master, GMS Golni Distt. Yamunanagar filed a Civil Writ Petition i.e. CWP No. 6566 of 2018- Raj Bal V/s State of Haryana & others stating therein that he be appointed with deemed date of appointment in November 1991, the date w.e.f. other persons of the same advertisement were selected as appointee. Before approaching the Hon'ble High Court, he alleged that he had got served a legal notice dated 09.06.2017 (P-8) but no action has been taken by the respondents thereon. On hearing the counsel for the petitioner, the Hon'ble High Court pleased to issue directions dated 25.05.2018 to respondent no. 2 to consider the legal notice dated 09.06.2017 and pass a speaking order thereon with a time bound manner, keeping in view the various judicial pronouncements and the prevalent law on the subject, specifically with in a period of six weeks from the date of receipt of certified copy of the order.

In pursuance of directions of Hon'ble High Court which were received in this Directorate, the claim of the petitioner for deemed appointment from November 1991 has been considered. It has been found that in the year 1990, the School Education Department Haryana got advertised 5070 posts of various cadres. Departmental Selection Committee(s) were constituted to conduct the interview. After due process of selection, the recommendations of successful candidates were issued and such candidates were issued appointment letters. The present petitioner remained unsuccessful in getting place in the selection list. The selection was challenged before Hon'ble High Court in various writ petitions but the matter got decided in CWP No. 16167 of 1991- Ramesh Chander V/s State of Haryana and others, decided on 07.02.1992. The selection lists were quashed. Thereafter, the Govt. of Haryana preferred an SLP i.e. SLP No. 4275 of 1992 before Hon'ble Supreme Court of India. While hearing before Hon'ble Supreme Court, the Govt. of Haryana submitted an undertaking that the eligible candidates/ petitioners, if any, would be considered against vacancy arisen during next one year and the high meritorious candidates would be given appointment against such vacant posts. No vacancy was displayed but the posts were again got advertised through Haryana Subordinate Selection Board in the year 1994. The candidates of advertisement 1990 again challenged the advertisement issued by Haryana Subordinate Selection Board by way of filing CWP No. 11974 of 1994- Virender Kumar & others V/s State of Haryana & others. Another writ petition i.e. CWP No. 6248 of 1994- Ramesh Chander V/s State of Haryana & others was also filed. The writ petitions have been allowed vide judgment dated 12.03.1996 and 19.11.1996. The respondents were directed to get display the vacancies available as well as list of candidates merit wise. Pursuant to these instructions, this department got published the vacancies of various cadres and merit list of candidates appeared before the interview committee in daily newspaper (Dainik Tribune) dated 01 & 02 July 1997. The successful candidates were asked to put forth their claim as per availability of vacancy subject to merit of the selection.


The petitioner, Sh. Raj Bal was granted opportunity of personal hearing twice on 06.07.2018 and 20.07.2018 with liberty to put all documentary proofs in his favour.

The petitioner appeared on both dates of hearing but failed to put forth any concrete proof or material which may prove that the petitioner remain successful in the first selection list which was challenged in CWP No. 16167 of 1991- Ramesh Chander V/s State of Haryana and others. It is relevant to state here that as per news paper dated 01.07.1997, there were 1199 vacancies of SS Master which came into existence during 08.10.1992 to 09.03.1994. These vacancies were further bifurcated as per roaster and only 620 vacancies were available for candidates of general category. Name of the petitioner has been shown at merit no. 640. Since, appointment orders were issued to the candidates upto merit no. 608 and merit no. of the present petitioner was 640, after due consideration his representation was rejected vide Order No. 24/6-97E-II(1) dated 16.09.1997 but later on he was issued appointment on regular basis vide this Directorate Order No. 24/9-1997E-II(1) dated 10.12.1998 in pursuance of judgment dated 19.11.1996 passed in CWP No. 6248 of 1994.

Considering all the facts and circumstances of the claim of the petitioner namely Sh. Raj Bal, it has been found that the claim of the petitioner was already reconsidered in light of judgment dated 19.11.1996 and the petitioner was satisfied on getting appointment on regular basis. He has concealed this fact from Hon'ble High Court and got issued present directions. However, it has been found that the petitioner has no locus standi to approach Hon'ble High Court again without any new materialistic and concrete proof of his merit. During hearing, he also failed to reply the same satisfactorily. After due consideration, I found no merit in the claim of the petitioner and found that the appointment order has rightly been issued to him as per merit list. No legal as well as statutory right of the petitioner has been infringed. Resultantly thereon, I found no merit, therefore, the claim of the petitioner for deemed date of appointment and seniority deserves to be declined.

I order accordingly.





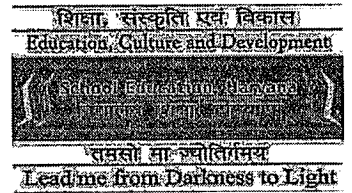
