

Whereas Sh. Kailash Chander, DPE, GSSS Chamarkhera Distt. Hisar now posted at GSSS Daulatpur (Hisar) was put under suspension on receiving complaint through DEEO Hisar. He was served charge sheet vide order dated 25.01.2017. On receiving reply to charge sheet, the delinquent now appellant, was reinstated in service without any prejudice to departmental enquiry vide order dated 12.04.2017. Thereafter, enquiry has been conducted and after due process of enquiry and granting opportunity of personal hearing, the disciplinary authority observed that a teacher should be a person of high moral and cordial behavior and found that the delinquent has paucity of such conduct/behavior and was awarded a punishment of stoppage of two increments without cumulative effect on delinquent, the present appeal was filed against this order.

On considering the contents of appeal, the appellant (Kailash Chander) has been granted opportunity to appear and produce all facts & documents during personal hearing on 06.02.2018. He appeared and was heard. After considering the relevant record, I am of the considered view that it seems to be a case of personal dispute, however possibility of professional lapses cannot be over-ruled. It seems that it would be justifiable to modify the order of punishment from stoppage of two increments without cumulative effect to one increment without cumulative effect.

I ordered accordingly.


