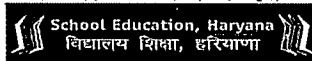



Whereas the delinquent i.e. Mukesh Kumar (Id.062241), TGT (SS), GMS Kemla Distt. Mahendergarh was served chargesheet under rule-7 of Haryana Civil Services (Punishment & Appeal) Rules, 2016 vide order dated 18.11.2016 on registration of FIR (No. 641 dated 17.12.2014) under Sections 294, 332, 353 and 506 IPC at Police Station Mahendergarh.
