Order No. 15/81-2016HRM-I(4)

Whereas Sh. Raghbir Saran, SS Master, GSSS Hamaul (Yamunanagar) now posted at GSSS Augangabad (Yamunanagar) filed a civil suit before Hon'ble Civil Court at Yamunanagar to get his date of birth rectified from 01.02.1965 to 08.05.1967. He submitted his certificate of birth issued by Additional District Registrar (Birth & Death) and District Health Officer, Yamunanagar issued under Birth And Death Registration Act, 1969 in which his date of birth has been defined 08.05.1967 and birth place at Khurdi (Yamunanagar). The Hon'ble Trial Court decreed the suit in his favour vide judgment dated 31.08.2009. Thereafter, the department preferred Civil Appeal (No. 280 of 2009) – Director General-cum- Commissioner, Secondary Education, Haryana & another V/s Raghbir Saran & another, on grounds of that the rectification in date of birth can only be sought within a period of two years from the date of joining Govt. service as provided under Annexure-A to Chapter-7 of Punjab Financial Rules Vol-I Part-I. The Hon'ble Appellate Court considered this provision but held that the provisions defined under Birth And Death Registration Act, 1969 would prevail over statutory rules. Hence, the date of birth i.e. 08.05.1967 as registered under this Act, 1969 cannot be disputed and date of birth recorded in school record deserves to be rectified accordingly.

Thereafter, necessary advice from office of District Attorney, Yamunanagar as well as L.R. Haryana has been sought which tendered advice dated 02.03.2016 that the matter is not fit for filing for RSA (Regular Second Appeal) before Hon'ble High Court.

Considering all facts and circumstances of the matter this Directorate is of considering view that the provisions of Statutory Act, 1969 would prevail over the provisions of Annexure-A Chapter-7 of Punjab Financial Rules Vol-I Part-I. Consequently it has been decided that the date of birth of the plaintiff i.e. Raghbir Saran deserves to be rectified from 01.02.1965 to 08.05.1967. Hence, it is advised to field offices that the necessary amendments regarding date of birth of concerned SS Master be made in his service record and the rectification be uploaded on MIS Portal.

Order accordingly.






