



Whereas Sh. Puneet Sagar, TGT Science, GSSS Palawas Distt. Bhiwani was served charge sheet under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules 2016 on 25.04.2017. He replied the same and on getting the reply unsatisfactory, due process of enquiry has been adopted under the principles of natural justice. The enquiry has been conducted by Sh. Balwan Singh, IAS (Retd.) who submitted his report dated 05.09.2017 stating therein that the prosecution has not been able to give any credible evidence to prove the charge, hence, the charges are proved.

Considering the contents of the enquiry report dated 05.09.2017 in the light of charges leveled upon the delinquent i.e. Sh. Puneet Sagar, the undersigned is satisfied with the enquiry report as sufficient evidence of misconduct are available on file.

The undersigned, being competent authority, is of considered view that the reply of the delinquent as well as enquiry report seem to be satisfactory one, hence it has been decided that a Show Cause Notice to delinquent be served stating therein why punishment of stoppage of two annual increment with cumulative effect be inflicted upon him. The delinquent i.e. Sh. Puneet Sagar was granted an opportunity to reply this Show Cause Notice within 15 days positively otherwise it would be presumed that he has nothing to say and further action be taken accordingly. In response, the delinquent demanded opportunity of personal hearing and the same was granted on 15.10.2018.

The delinquent i.e. Sh. Puneet Sagar appeared in person and heard. After considering the circumstances, detailed by the delinquent a lenient view has been taken and punishment of stoppage of one increment with cumulative effect has been inflicted upon the delinquent. Further the absent period from duty i.e. 30.03.2017 to 14.08.2018 has been ordered to be treated as leave of kind due for all intents and purposes.




