This is in continuation of orders dated 30.07.2018 vide which it was ordered that the cases in which compliance to the speaking orders issued by the Directorate in compliance, to the judgement orders announced by the Hon'ble High Court similar to the case of Neelam Rani vs State and others may be got verified from the Section Officer posted in the office of District Education Officer in their district in case the post of Section Officer is vacant in their office.

While reviewing the latest status of court cases pending in the Directorate as well in the field offices besides the other office matters today dated 15.09.2018, it has been brought to the notice of the undersigned by the DEEO, Panipat/Ambala/Hisar/Charkhi Dadri & Sirsa that the post of Section Officer is lying vacant in their office as well as in the office of District Education Officer. Furthermore, in any case, the post of Accounts Officer in the office of District Project Co-ordinator, Sarv Siksha Abhiyan is also vacant in their district then the same may be got verified from the Accounts Officer posted in the office of District Project Co-ordinator, Sarv Siksha Abhiyan of the neighbouring district. The compliance report should be sent to the concerned branches of the Directorate latest by 22.09.2018.
