Whereas Smt. Archana, TGT SS, GSSS Manoharpur Distt. Jind was served upon charge sheet under Rule-7 of Haryana Civil Services (Punishment & Appeal) Rules 2016 on 15.09.2017 but she did not reply and only a request dated 16.07.2014 for extra ordinary leave received from abroad i.e. Canada which is sufficient to prove that the delinquent resides in Canada.

On getting no reply, due process of enquiry has been adopted under the principles of natural justice. The enquiry has been conducted by Sh.R.P.Bhasin, Sessions & District Judge (Retd.) who submitted his report dated 13.08.2018 stating therein that the prosecution has successfully proved the charge. Accordingly, the charges leveled upon delinquent stands prove.

Considering the contents of the enquiry report dated 13.08.2018 in the light documents available on file, I being Disciplinary Authority, am fully satisfied with the enquiry report.

Before taking further disciplinary action, the undersigned, being competent authority, is of considered view that the reply of the delinquent deserves to be punished for the misconduct, but before inflicting punishment upon delinquent, it is decided that a Show Cause Notice to delinquent be served stating therein why punishment of stoppage of one annual increment with cumulative effect be inflicted upon her. The delinquent i.e. Smt. Archana, TGT SS, GSSS Manoharpur Distt. Jind is granted an opportunity to reply this notice within 15 days positively otherwise it is presumed that she has nothing to say and further action be taken accordingly.
