



Whereas Sh. Hakumuddin S/o Jagrup Khan, JBT, GPS Adbar, Block-Nuh (Mewat) now posted as SS Master GMS Chandeni (Nuh) was granted promotion vide this Directorate Order No. 2/34-2012HRM-I(2) dated 30.07.2012 with effect from 12.12.2010. Thereafter, on reconsideration of the facts it has been found that the petitioner passed his B.Ed. Part-II (Final) on 10.01.2011, hence, he was found not entitled to this promotion w.e.f. 12.12.2010. He was served a notice before reversion to his initial post (JBT) under the principles of natural justice. He failed to prove his eligibility for promotion on 12.12.2010, consequently thereon he was reverted to his initial post of JBT vide this Directorate order dated 26.11.2015. Sh. Hakumuddin challenged that notice before Hon'ble High Court by way of filing CWP No. 26233 of 2015- Hakumuddin V/s State of Haryana. The Hon'ble Court pleased to stay the order of reversion vide its order dated 17.12.2015.

The Hon'ble Court considered that the order of promotion has been passed on 30.07.2012 whereas the cut of date of eligibility has been mentioned as 29.10.2010/ 12.12.2010. It has been found that on the date of order of promotion i.e. 30.07.2012, the petitioner i.e. Hakumuddin has been found eligible for promotion, resultantly thereon, the Hon'ble court quashed the impugned order of reversion dated 26.11.2015 and allowed the writ petition with all consequential benefits including monetary benefits for the intervening period from the date of reversion order till date i.e. 12.01.2017. The Hon'ble Court further ordered that the monetary benefits like difference of salary/pay shall be released within a period of 3 months from today.

Perusing the Hon'ble Court dated 12.01.2017, the order of reversion have been withdrawn and the petitioner i.e. namely Hakumuddin was granted opportunity of personal hearing on 10.07.2018 to appear and put forth all his monetary claims. Since, the order of reversion dated 26.11.2015 was stayed by Hon'ble Court by 17.12.2015 resultantly thereon, the petitioner has been found that he never joined back as JBT in compliance of the reversion order dated 26.11.2015. He performed his duties as SS Master and got salary for the post of SS Master during all the intervening period. The petitioner did not appear before undersigned, the reason best known to him but as per office record it has been found that no monetary loss is caused to petitioner therefore no further action is required in this matter. Considering all the facts and circumstances, I am of the considered view that no further action is required in this matter, consequently thereon I order to file the matter and inform the petitioner about the same accordingly.
