Whereas, Sh. Karan Singh rendering service on post of Elementary School Headmaster (i.e. ESHM) Government Middle School Gopalwas Distt. Bhiwani submitted his claim for grant of benefit of 2nd Assured Career Progression (ACP), counting his regular satisfactory service in same and identical pay scale from the date he got promotion to post of Head Teacher Primary School i.e. 12.10.2001. He submitted that the pay scale of Head Teacher/Sanskrit Teacher/TGT(Master) are identical and same.

After getting the case, the entitlement for grant of 2nd ACP Pay scale has been considered in light of statutory financial rules, issued by Finance Department Haryana vide notification dated 07.01.1998/30.12.2008 or 28.10.2016. Finding his claim untenable under these rules, the applicant i.e. Sh. Karan Singh has been granted opportunity of personal hearing with liberty to put forth all relevant documents and statutory rules in favour at the time of hearing i.e. on 17.09.2018.

The applicant appeared in person and heard on 17.09.2018. During hearing, the applicant failed to submit any concrete material in form of documents and rules which may hold him entitled for grant of 2nd ACP on completion of 16 years regular satisfactory service in a pay scale of TGT Cadre.

The claim of the applicant has also been considered in light of his service record. It has been found that the applicant joined his services as regular incumbent on 12.10.1995 on post of JBT now PRT. Being a JBT/PRT of reserved category of scheduled caste, he has been granted promotion to post of Head Teacher, Primary school on 12.10.2001 on completion of 6 years service. Thereafter, he has again been granted fresh promotion from post of JBT to post of Sanskrit teacher w.e.f. 02.12.2003. It means that he has voluntarily relinquished the post of Head Teacher since there is no provision to grant promotion to post of Sanskrit Teacher from post of Head Teacher. Therefore, the promotion cadre can only be considered w.e.f. 02.12.2003 i.e. joining as Sanskrit Teacher.

As per rule 13 (Note-2) of the latest Haryana Civil Services (ACP) Rules, 2016, the 2nd ACP pay scale can only be granted on completion of 16 years regular satisfactory service on promotional post. The applicant has not completed this required statutory length of regular satisfactory service. Hence, the claim is found untenable.

Considering the claim for 2nd ACP pay scale from all angles, it is found that the applicant may only be considerable for this benefit on completion of 16 years regular satisfactory service on promotional post which can only be completed on 01.12.2019 or on completion of 24 years regular satisfactory service as fresh entrant (JBT) which completes on 11.10.2019. The applicant has to opt any of these two dates for this benefit till then the claim deserves to be rejected.

I pass order accordingly.

Whereas, Hon'ble Punjab and Haryana High Court vide its order dated 04.07.2017 in CWP No. 5959 of 2017 titled as Sunita & others Versus State of Haryana & Others directed as under :-

"For detailed orders, see order of even date passed in CWP No.12822 of 2015, titled as Bhushan Kumar and others Vs State of Haryana and others."

Order passed in CWP No.12822 of 2015, titled as Bhushan Kumar and others Vs State of Haryana and others is as under:-

"In view of above, all these petitions are disposed of with a direction to the appropriate authorities to take a decision in each case of the petitioners, on merits, in terms of the judgment in Neelam Ranis' case (supra), which has attained finality up to the Supreme Court, within a period of five months from the date of receipt of a certified copy of this order.

As all these cases are being dispose of en masse, liberty is given to the State to point out anything specific in individual cases, if there is some specific issue."

In pursuance of the order dated 04.07.2017 it has been examined.

The Hon'ble High Court vide judgment dated 30.10.2017 passed in a bunch of 39 writ petitions mainly CWP No. 15280 of 2017 titled as Sudhir Kumar & Others versus State of Haryana & Others. The operative part of the judgment dated 30.10.2017 passed in CWP No. 15280 of 2017 – Sudhir Kumar & Others versus State of Haryana & Others reads as under:-

"Consequently, these petitions are allowed in the same terms as Neelam Rani's case (Supra), with the competent authority amongst the respondents directed to consider the case of each of the petitioners for stepping up their pay scales to the level of their juniors, as per the ratio of the aforesaid judgment, and pass a speaking order thereafter. The speaking order shall be passed in the case of each petitioner/identical set of petitioners within a period of 4 months from the date of receipt of a certified

If the case of each/any petitioner(s) is found to be covered by the decision in that case, the arrears of difference of pay be released to them within another period of 3 months thereafter, but with such arrears restricted to a period of 3 years and 2 months prior to the date of filing of the petition before this Court, by each particular petitioners. On such arrears, the petitioners would also be entitled to interest @ 6% per annum, as was granted in Neelam Rani's case."

That the Finance Department vide order dated 21.11.2017, has extended the benefit of stepping up of pay to all eligible teachers / masters in terms of judgment dated 15.05.2013 passed in CWP No. 11254 of 2010 - Neelam Rani Vs State of Haryana.

Further in CWP No. 14830 of 2017, the Hon'ble Punjab & Haryana High Court vide its order dated 20.12.2017 in CWP No. 14830 of 2017 titled as Ram Parsad & Others Vs State of Haryana & others directed as under:-

"Accordingly, the present writ petitions are disposed of, with a direction to the competent authorities, to take into consideration the above-said decision of the State Government dated 21.11.2017 and process the case of the petitioners on individual basis and pass orders, accordingly, within a period of 4 months from the receipt of a certified copy of this order. It will be open to respondent No.1 to nominate a designated competent authority so that no contradictory orders are passed. Wherever the relief is to be granted, the benefits be paid forthwith, as per the decision of the State Government. In case the necessary relief is to be denied, speaking order be passed and communicated to the concerned petitioner(s)."

Since, two sets of order have been passed by different Hon'ble Benches of Punjab and Haryana High Court, therefore, the matter was again submitted to Finance Department Haryana for advice. Considering the issues raised by the Department, the Finance Department Haryana vide U.O No. 6/42/2011-4 PR (FD) 82 dated 13.02.2018 advised the Department to consider the case of each and every Petitioner/Teacher in light of following observations:-

- (a) While extending the benefit of stepping-up under aforesaid FD letter dated 21.11.2017, the seniority as per service rules may only be kept in view as any violation thereof may not only result in avoidable overpayment of Govt. Funds to non-entitled personnel but may also be leading to set in motion a chain of endless litigation. Hence it has been advised that while extending the benefit of stepping-up, the issue of seniority as provided under Service Rules be taken into account.**
- (b) The Finance Department further advised that there is no limitation of period of payment of pay arrears. The benefit of stepping-up may be allowed to an eligible employee on actual basis from the date it becomes due. So far as reference to judgment dated 30-10-2017, in CWP No. 15280 of 2017- Sudhir Kumar & others versus State of Haryana & others is concerned, it is clarified that the beneficiary employees may be given an option to receive this benefit as per this judgment i.e. restriction of arrears for 38 months only prior to filing of concerned CWP alongwith interest @ 6% p.a. OR to receive this benefit in terms of FD instructions dated 21-11-2017 on**

actual basis from the date it becomes due without interest. The option from concerned employee be sought within a month.

(c) In reply to issue (c), It has been advised that there is no contradiction in FD advice dated 21-11-2017 and W/CS letter dated 08-05-2017. Both have been issued to minimize the litigation, accordingly, FD order dated 21-11-2017 be implemented.

Considering the judgments passed by Hon'ble Punjab and Haryana High Court in light of Finance Department orders and advice, it has been decided that the competent authority i.e. Drawing & Disbursing Officer would consider the claim of the claimant Teacher in the light of above said observations and take an option from the claimant as specified in para (b) above before extending the benefits of stepping up of pay at par with Junior and compliance report be submitted to Directorate positively.

I order accordingly.

ORDER

Order No. 17/57-2018 HRM.I(2) Dated, Panchkula, the 18.10.2018

Whereas, Sh. Mukesh Sharma and Others, JBT Teacher filed C.W.P. No. 14714 of 2018 titled as Mukesh Sharma and Others Vs State of Haryana & Others. The Hon'ble High Court vide order dated 31.05.2018 disposed of the said writ petition with the following orders:

"The writ petition is disposed of with a direction to Director School Education-Respondent no. 2 to objectively decide the representation dated 22.05.2018 (Annexure P-12), by passing a speaking order thereupon, within a period of eight weeks from the date of receipt of a certified copy of this order".

In compliance of the above mentioned order, the representation dated 22.05.2018 (Annexure P=12) has been examined. The petitioners in the representation submitted that this department vide letter dated 27.04.2018 invited applications for promotion to the posts of TGT in English, Science, Arts, Physical Education, Home Science, Music, Urdu, Sanskrit and Punjabi. But the applications were not invited in the subjects like Hindi, Social Science and Maths. They have submitted that there are vacancy of these subjects and requested to invite application for promotion to the post of TGT in the respective subjects i.e Hindi, Social Science and Mathematics.

The petitioners were afforded the opportunity of personal hearing and they were called on 14.09.2018. The petitioners were heard and they reiterated their submissions made in the representation dated 22.05.2018.


That as on 14.08.2018, 1400 post of Mathematics subject, 4540 post of Social Studies subject and 497 post of Hindi subject (including Guests) are surplus.

I have peruse the official record and after hearing the petitioners. I am of the considered view that since we have surplus teachers in Hindi, SS and Maths, so promotions in these subjects cannot be done. Hence,



the representation of the petitioners dated 22.05.2018 (Annexure-P-12) is hereby rejected.

Whereas, Sh. Kanwar Singh rendering service on post of S.S Master, Government Senior Secondary School Kharkhoda submitted his application to the DEEO Sonapat for grant of benefit of 2nd Assured Career Progression (ACP), counting his regular satisfactory service from the date he got promotion to post of Head Teacher Primary School vide DPEO Gurgaon order No. E-1/2001-2629-2680 dated 27.09.2001 and he joined on 01.10.2001. He submitted that the pay scale of Head Teacher and TGT (Master) are identical and same.

Sh. Kanwar Singh joined his services as regular incumbent on 22.04.1995 on post of JBT now PRT. Being a JBT/PRT of reserved category of scheduled caste, he has been granted promotion to the post of Head Teacher, Primary school on 01.10.2001 on completion of 6 years service. Thereafter, he has again been granted fresh promotion from post of JBT to post of S.S Master vide order No. 2/9-2008-HRM-I(4) dated 13.10.2010 and joined on 28.10.2010. It means that he has voluntarily relinquished the post of Head Teacher since there is no provision to grant promotion to post of S.S Master from the post of Head Teacher.

The entitlement for grant of 2nd ACP Pay scale has been considered in light of statutory financial rules, issued by Finance Department Haryana vide notification dated 07.01.1998/30.12.2008 or 28.10.2016.

He is not covered under Rule 7(i), 7(ii), 7(iii), 7(iv) & as per Rule 13 of ACP Rule 2008 and also as per Note-2 below rule 13 of Haryana Civil Services (Pay) Rules, 2016, the 2nd ACP pay scale can only be granted on completion of 16 years regular satisfactory service on promotional post. The applicant has not completed this required statutory length of regular satisfactory service. Hence, the claim of 1st ACP w.e.f 01.10.2011 as Head Teacher is not admissible to him rather it will be admissible w.e.f 04.03.2014 as JBT on completion of 16 years regular satisfactory services as per Government of Haryana Finance Department No. 1/83/2008-1 PR(FD) Dated, Chandigarh the 4th March, 2014 whereby the period of 10, 20 and 30 years of service has been reduced to 8, 16 and 24 years. He was wrongly given the benefit of 1st ACP w.e.f 01.10.2011, which is to be re-fixed but before doing so, Sh. Kanwar Singh vide this office letter Memo No. 5/85-2018 HRM-II(6) dated 13.08.2018 has been granted opportunity of personal hearing with liberty to put forth all relevant documents and statutory rules in favour at the time of hearing i.e. on 13.09.2018. The applicant appeared in person and heard on 13.09.2018. During hearing, the applicant failed to submit any

concrete material in form of documents and rules which may hold him entitled for grant of 2nd ACP w.e.f. 01.10.2017 on completion of 16 years regular satisfactory service in a pay scale of TGT Cadre.

Considering the claim of the applicant, it has been found that he has been granted promotion from feeder post of JBT to Head Teacher on 01.10.2001 and thereafter he has been granted 2nd benefit in form of 1st ACP as Head Teacher on 01.10.2011. Since the applicant has opted pay scale of Head Teacher even after joining on post of SS Master on 28.10.2010. Therefore, the claim of 1st ACP w.e.f 01.10.2011 as Head Teacher is not admissible to him and he is not covered under Rule 7(i), 7(ii), 7(iii), 7(iv) & as per Rule 13 of ACP Rule 2008 and also as per Note-2 below rule 13 of Haryana Civil Services (Pay) Rules, 2016 rather 2nd ACP is admissible w.e.f 04.03.2014 as JBT on completion of 16 years regular satisfactory services.

In view of the above, the pay of Sh. Kanwar Singh, S.S Master, Government Senior Secondary School Kharkhoda Distt. Sonapat be rectified and re-fixed.

I pass order accordingly.
