**Subject:- For Relaxing the Land Requirement Norms for Opening/Upgradation of Government Schools in NCR Areas (CBSE Pattern).**

The relaxed norms for opening of new schools and upgradation of schools in NCR Area according to CBSE parameters will, henceforth, be as under :-

In view of the special conditions of Faridabad, Gurugram and Panchkula Cities due to high density of population and non-availability of sufficient land, the issue of relaxing the land norms for opening/upgradation of schools in these cities has been engaging the attention of State Government. To sustain the school availability, the land norms in respect of these cities framed as under:-

| (a) Primary School          | - 0.5 Acre |
| (b) Middle School           | - 1 Acre   |
| (c) Senior Secondary School | - 1 Acre   |

The other conditions for opening/upgradation of schools will remain same as per the memo no. 2/21-2008 S.E (3) dated 11-10-2010 regarding opening/upgradation of Government Schools. Further, it is made clear that the opening/upgradation of government schools in all other areas which are not included in the revised norms will be done as per norms mentioned in the memo no. 2/21-2008 S.E (3) dated 11-10-2010.
